The Department of Wildlife and Fisheries, if the collateral for a secured transaction (2) is a titled vessel valued in excess of \$2,500 and required to be numbered, or a titled

Requires the filing office to notify the secretary of state, or his designee, within 24 hours following the discovery of a cyber incident that impacts the filing office, including but not limited to a computer system maintained by the secretary of state.

<u>Present law</u> provides for the powers and duties of registrars of voters.

<u>Proposed law</u> retains <u>present law</u> and requires the registrar to notify the secretary of state, or his designee, within 24 hours following the discovery of a cyber incident that impacts the office of the registrar, including but not limited to a computer system maintained by the secretary of state.

<u>Present law</u> provides for the powers and duties of clerks of court as the chief election officer of the parish.

<u>Proposed law</u> retains <u>present law</u> and requires the clerk of court to notify the secretary of state, or his designee, within 24 hours following the discovery of a cyber incident that impacts the office of the clerk of court, including but not limited to a computer system maintained by the secretary of state.

<u>Proposed law</u> defines "cyber incident" as an event that may jeopardize the confidentiality, integrity, or availability of digital information or information systems.

Effective August 1, 2020.
