15	Be it enacted by the Legislature of Louisiana:
16	Section 1. R.S. 15:539.1 and 539.3(A) are hereby amended and reenacted to read as

3	A. Upon conviction of a human trafficking-related offense as defined in
4	R.S. 46:1844(W)(2)(a), any felony sex offense as defined in R.S.
5	46:1844(W)(2)(b), R.S. 14:40.3 (cyberstalking), R.S. 14:81.1.1 (Sexting;
6	prohibited acts; penalties), R.S. 14:283.2 (nonconsensual disclosure of a private
7	image), R.S. 14:78 (incest) as that offense existed prior to its repeal by Acts

12	that the personal property used in the commission of the offense be seized or
13	impounded and sold at public sale or auction by the district attorney or
14	otherwise distributed or disposed of in accordance with the provisions of this
15	Section. The personal property made subject to seizure and disposition
16	pursuant to this Section may include any electronic communication devices,
17	computers, computer related equipment, motor vehicles, photographic
18	equipment used to record or create still or moving visual images of any victim
19	that are recorded on paper, film, video tape, disc, or any other type of digital
20	recording media, currency, instruments, or securities. Forfeiture of personal
21	property under the provisions of this Section shall not preclude the application
22	of any other remedy, civil or criminal, under any other provision of law. All
23	materials seized as evidence in an offense enumerated in this Section shall
24	constitute contraband. The court, upon motion of the prosecuting attorney,
25	after contradictory hearing, shall order the destruction of the contraband when
26	it is determined that it is no longer needed as evidence.

B.C.(1) The personal property shall be exempt from sale and the currency, 14 instruments, or securities shall be exempt from distribution or disposition if it was 15 16 stolen or if the possessor of the property was not the owner and the owner did not know that the personal property was being used in the commission of the crime. If 17 18 this exemption is applicable, the personal property shall not be released until such 19 time as all applicable fees related to its seizure and storage are paid. An internet 20 service provider shall not be required to pay seizure or storage fees to secure the 21 release of equipment leased to an offender.

(2) Property subject to forfeiture pursuant to the provisions of this Section
shall be exempt from forfeiture when a spouse, co-owner, or interest holder in the
property establishes by sworn affidavit executed before a notary public the
following:

26 (a) That he had no knowledge of the commission of the criminal conduct and
27 could not have reasonably known of the conduct.

(b) That he did not consent to the use of property in the commission of thecriminal conduct.

7	C. <u>D</u> . In addition, the personal property shall be exempt from sale and the
8	currency, instruments, or securities shall be exempt from distribution or disposition
9	if it is subject to a lien recorded prior to the date of the offense and if the applicable
10	fees related to the property's seizure and storage are paid by a valid lien holder.
11	\mathbf{D} . E. The proceeds of the public sale or public auction shall pay the costs of

17	A. A person convicted of a violation of R.S. 14:46.2 (human trafficking), R.S.
18	14:46.3 (trafficking of children for sexual purposes), R.S. 14:81.1 (pornography
19	involving juveniles), R.S. 14:81.3 (computer-aided solicitation of a minor), R.S.
20	14:82.1 (prostitution; persons under eighteen; additional offenses), R.S. 14:83
21	(soliciting for prostitutes), R.S. 14:83.1 (inciting prostitution), R.S. 14:83.2
22	(promoting prostitution), R.S. 14:84 (pandering), R.S. 14:86 (enticing persons into

5	the gross income or value to the defendant of the victim's labor or services engaged
6	in by the victim while in the human trafficking situation. In the case of sex
7	trafficking, the victim shall be entitled to restitution for the income he would have
8	earned, had he not been victimized, as guaranteed under the minimum wage and
9	overtime provisions of the federal Fair Labor Standards Act.
10	(4) Return of property, cost of damage to property, or full value of property
11	if destroyed or damaged beyond repair.
12	(5) Expenses incurred by the victim and any household members or other
13	family members in relocating away from the defendant or the defendant's associates,
14	including but not limited to deposits for utilities and telephone service, deposits for
15	rental housing, temporary lodging and food expenses, clothing, and personal items.
16	Expenses incurred pursuant to this Section shall be verified by law enforcement to
17	be necessary for the personal safety of the victim or household or family members,
18	or by a mental health treatment provider to be necessary for the emotional well-being
19	of the victim.

<u>Present law</u> requires personal property to be forfeited following the conviction of certain sex offenses.

<u>Present law</u> requires the district attorney to conduct a public sale or public auction to sell or auction property forfeited following the conviction of certain sex offenses otherwise required by <u>present law</u> to be destroyed.

<u>Proposed law</u> removes misdemeanor offenses and includes all felony sex offenses from the list of offenses subject to asset forfeiture and sale. <u>Proposed law</u> further provides for the destruction of forfeited property upon motion of the district attorney and, after a contradictory hearing, that the seized property is no longer needed as evidence.

<u>Present law</u> provides that the proceeds received from the sale or auction of the forfeited property be used to pay the costs of the public sale or auction, court costs, and fees related to seizure and storage of the property. <u>Present law</u> further provides that the restitution granted to the victim be paid after the foregoing costs are satisfied.

Proposed law retains present law.

<u>Proposed law</u> deletes from <u>present law</u> provisions relative to forfeiture and sale of property and disposition of evidence relative to certain sex offenses that are redundant with <u>proposed</u> law.
