9 (4) "Family members" means spouses, former spouses, parents and children,
10 stepparents, stepchildren, foster parents, and foster children. "Household members"
11 means any person presently or formerly living in the same residence with the
12 defendant and who is involved or has been involved in a sexual or intimate
13 relationship with the defendant ~~and who is seeking protection under this Part~~, **or any**
14 **child presently or formerly living in the same residence with the defendant, or**
15 **any child of the defendant regardless of where the child resides**. "Dating partner"
16 means any person protected from violence under R.S. 46:2151 ~~who is seeking~~
17 ~~protection under this Part~~. If a parent or grandparent is being abused by an adult
18 child, adult foster child, or adult grandchild, the provisions of this Part shall apply
19 to any proceeding brought in district court."
