2 On page 1, line 5, after "terms" insert ", definitions,"

4 On page 1, line 11, after "~~(59)~~" insert "(a)"

5 AMENDMENT NO. 3

6 On page 1, delete line 12 and insert "**any employee whose information is required to be**
7 **submitted by an employer pursuant to**"

8 AMENDMENT NO. 4

9 On page 1, line 13, change "**contract**" to "**an agreement**" and after "**for any**" delete the
10 remainder of the line and delete lines 14 and 15, and insert "**incentive program or**
11 **discretionary inducement. This information shall be confidential pursuant to R.S.**
12 **44:22.2.**

13 **(b) As used in this Paragraph:**

14 **(i) "Employee" means a natural person who is paid compensation in**
15 **return for the performance of services. An employee includes but is not limited**
16 **to any person who is paid a salary, hourly wage, or commission in exchange for**
17 **their performance of the services.**

18 **(ii) "Employer" means a person, association, or legal or commercial**
19 **entity receiving services from an employee and, in return, giving compensation**
20 **of any kind to an employee."**

24 On page 2, line 3, after "**submitted**" insert "**by an employer**"

25 AMENDMENT NO. 7

26 On page 2, delete lines 4 through 6 and insert "**to an agreement with the Department of**
27 **Economic Development for any incentive program or discretionary inducement shall**
28 **be confidential and shall not be subject to the provisions of R.S. 44:31, 32, or 33."**

29 AMENDMENT NO. 8

30 On page 2, delete line 7, and insert:
