LEGISLATIVE PROCEDURE RE NO IMPACT See Note (Constitutional Amendment) Provides for laws relative to statutory dedications.

The proposed constitutional amendment requires enactment of a law by 2/3 of the members of each house of the legislature to create a protected special fund in the state treasury, to increase or decrease the amount of monies dedicated to the protected special fund, or to modify the purposes for which monies in the protected special fund may be used. The proposed amendment shall be submitted to the electors at the statewide election to be held on November 3, 2020.
