1 AMENDMENT NO. 1

2 On page 1, line 2, change "Promotions" to "Reform"

3 AMENDMENT NO. 2

4 On page 1, line 3, after "regarding" delete the remainder of the line and delete line 4 in its
5 entirety and insert "all aspects of the municipal fire and police civil service system, including
6 the promotion of employees of fire and police departments and to"

7 AMENDMENT NO. 3

8 On page 1, at the end of line 5, delete "methods" and on line 6, delete "for the promotion of
9 such employees" and insert "strategies and procedures for the administration of the system
10 and the management of such employees"

11 AMENDMENT NO. 4

12 On page 1, between lines 16 and 17, insert the following:

13 "WHEREAS, the Louisiana Legislature has enacted many bills over the years to
14 change the municipal fire and police civil service laws, and these changes have directly
15 impacted the employment of firemen and policemen throughout the state of Louisiana; and

16 WHEREAS, in recent years, many have taken a particular interest in amending the
17 municipal fire and police civil service laws relative to the promotion of firemen and
18 policemen; and"

20 On page 2, line 12, after "the" and before "law enforcement" insert "fire protection and"

21 AMENDMENT NO. 6

22 On page 2, line 14, after "viability of" and before "police" delete "municipal" and insert "fire
23 and"

24 AMENDMENT NO. 7

25 On page 2, line 15, after "expanding" and before "law" insert "fire protection and"

26 AMENDMENT NO. 8

27 On page 2, line 16, delete "police"

28 AMENDMENT NO. 9

29 On page 2, line 17, after "facing" and before "law" insert "fire protection and"

1 AMENDMENT NO. 10

2 On page 2, delete lines 18 through 21 in their entirety and insert the following:

3 "WHEREAS, the stakeholders have expressed interest in making changes in the
4 municipal fire and police civil service system particularly with regard to promotions within
5 the system, but have also expressed their desire that a compromise agreement be put forth
6 by those who are proposing changes to the system and those who are opposed to such
7 changes."

8 AMENDMENT NO. 11

9 On page 2, delete lines 24 and 25 in their entirety and insert "Civil Service Reform to study
10 and make recommendations regarding all aspects of the municipal fire and police civil
11 service system, including the promotion of employees of fire and police"

12 AMENDMENT NO. 12

13 On page 2, at the end of line 26, delete "methods for" and at the beginning of line 27, delete
14 "the promotion of such employees" and insert "strategies and procedures for the
15 administration of the system and the management of such employees"

16 AMENDMENT NO. 13

17 On page 3, line 10, after "of the" and before "or his" delete "Louisiana Union of Police" and
18 insert "Louisiana AFL-CIO"

19 AMENDMENT NO. 14

20 On page 3, line 11, after "of the" and before "or his" delete "International Union of Police"
21 and insert "Louisiana Law Enforcement Association"

22 AMENDMENT NO. 15

23 On page 3, delete lines 15 through 18 in their entirety and insert the following:

- 24 "(11) The president of the Professional Fire Fighters Association of Louisiana or his
25 designee.
26 (12) The president of the Louisiana Municipal Association or his designee.
27 (13) The president of the Louisiana Fire Chiefs Association or his designee."

28 AMENDMENT NO. 16

29 On page 3, line 19, after "chairman" and before "shall" insert "of the House Committee on
30 Municipal, Parochial and Cultural Affairs or his designee"

31 AMENDMENT NO. 17

32 On page 3, between lines 20 and 21, insert the following:

33 "BE IT FURTHER RESOLVED that at the first meeting the members shall elect a
34 chairman and a vice chairman."
