HIGHER EDUCATION RE1 DECREASE SG RV See Note
Prohibits a postsecondary education institution from withholding certain student services for financial reasons

Proposed legislation authorizes public post secondary education management boards to adopt policies allowing institutions to refuse to provide a transcript for current or former students on the grounds that the student owes a debt; condition provision of the transcript on a payment of the debt; charge a higher fee because the student owes a debt; or use the transcript as a debt collection tool. Further, would allow an institutions to withhold services from a student who is in default on a federal loan, including providing grades, diplomas, course registration services, or transcripts.
