HOUSE BILL NO. 2

BY REPRESENTATIVE BISHOP AND SENATOR ALLAIN

CAPITAL OUTLAY: Provides for the comprehensive Capital Outlay budget (Item #7)

1 AN ACT

2 To provide with respect to the capital outlay budget and the capital outlay program for state
3 government, state institutions, and other public entities; to provide for the
4 designation of projects and improvements; to provide for the financing thereof
5 making appropriations from certain sources; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. The following sums or so much thereof as may be necessary are hereby
8 appropriated out of any monies in the state treasury from the sources specified, from federal
9 funds and self-generated revenues belonging to the state of Louisiana and/or collected by
10 boards, commissions, departments, and agencies thereof, all for making capital outlay and
11 for the purposes and in the amounts specified herein for the Fiscal Year commencing July
12 1, 2020, and ending June 30, 2021, subject to the conditions thereafter provided:

13 A project with funding payable from General Obligation Bonds Priority 1 indicates
14 that the funding for the project includes the reauthorization of funding which was previously
15 granted as a line of credit by the State Bond Commission in Fiscal Year 2019-2020. As used
16 in this Section, the term "general obligation bonds" means state general obligation bonds or
17 other evidences of indebtedness payable from the Bond Security and Redemption Fund. The
18 amount set forth in this Section opposite each project, or so much thereof as may be
19 necessary, is hereby appropriated and payable from the source of funding indicated;
20 provided, however, amounts appropriated and payable from federal funds may be

1 encumbered or expended only to the extent such amounts shall have been committed or
2 received. Pursuant to the provisions of R.S. 39:82, funds for planning, acquisition,
3 construction, and major repair projects appropriated by this Act may be retained until
4 completion of the project, even if no bona fide liability exists on the last day of the fiscal
5 year.

6 This Act shall constitute the comprehensive state capital outlay budget for the 2020-
7 2021 Fiscal Year. Projects set forth which are payable from the proceeds available from the
8 sale of general obligation bonds shall have the priorities as indicated. The Request for Line
9 of Credit form used by the attorney general and Bond Counsel in evaluating Louisiana
10 Constitutional, Internal Revenue Code, and applicable income tax regulations shall be filed
11 with the commissioner of administration, State Bond Commission, and state attorney
12 general. No general obligation bond cash lines of credit shall be granted to fund any lower
13 priority project prior to the granting of general obligation bond cash lines of credit to fund
14 all higher priority projects (the "general rule"), except as hereinafter provided. This
15 prohibition against funding a lower priority project shall not apply upon a showing of an
16 impossibility or impracticality either to proceed with all unfunded higher priority projects
17 or to proceed with the funding of such projects or any part thereof through the issuance of
18 general obligation bonds for any reason. Such showing shall be stated in reasonable detail
19 in a certificate or certificates signed by the state agency responsible for administering the
20 funding, and filed with the commissioner of administration and the State Bond Commission
21 (hereinafter referred to as "the Commission"). Upon a determination by the Commission
22 that proceeding with such a project or the funding thereof through the issuance of general
23 obligation bonds is impractical or impossible, the Commission may then proceed with the
24 sale of general obligation bonds or the granting of cash lines of credit without regard to the
25 priority of the unfunded projects determined to be impossible or impractical.

26 Upon recommendation by the state agency responsible for administering the funding,
27 if it is determined at any time that proceeding with the project or with the funding thereof
28 is no longer impossible or impractical, the State Bond Commission may rescind the
29 certificate of impossibility or impracticality and may proceed with the project or with the

1 issuance of general obligation bonds or the granting of cash lines of credit to fund the
2 project. Alternatively, the Interim Emergency Board (hereinafter referred to as "the Board"),
3 upon reviewing certificates as described above and determining that proceeding with such
4 project or the funding thereof through the issuance of general obligation bonds is impossible
5 or impractical, may designate a lower priority for such project. The Board's determination
6 and lower priority designation shall be submitted to the members of the legislature for their
7 approval in accordance with the provisions of Chapter 3-B of Subtitle I of Title 39 of the
8 Louisiana Revised Statutes of 1950. In accordance with the provisions of Chapter 3-B of
9 Subtitle I of Title 39 of the Louisiana Revised Statutes of 1950, whenever at the written
10 request of the appropriate legislators and agency, the Board determines that an adjustment
11 to a project description originally set forth in such capital budget adopted by the legislature
12 for a current fiscal year is necessary to correct a mistake in a project description, clarify a
13 description, change the scope of a description, or make any other adjustment the Board
14 deems necessary to implement the purpose of the project, such adjustment shall become
15 effective only upon the approval by majority vote of the elected members of each house of
16 the legislature in the manner provided for in Chapter 3-B of Subtitle I of Title 39 of the
17 Louisiana Revised Statutes of 1950.

18 If such approval is granted, notification by the chair or secretary of the Board of the
19 results of the balloting shall be transmitted to the State Bond Commission, which may then
20 proceed with the sale of general obligation bonds or the granting of cash lines of credit for
21 each change approved upon request of the commissioner of administration in accordance
22 with the general rule.

23 With respect to Priorities 1 through 5, a lower priority project may be moved to a
24 higher priority only upon a showing of an emergency or other cause not reasonably
25 anticipated by the legislature, which shall be stated in reasonable detail in a certificate signed
26 by the head of the appropriate department, political subdivision, or agency and filed with the
27 commissioner of administration and the Board. Upon a determination by the Board that such
28 project should be moved to a higher priority because of an emergency or other cause not
29 reasonably anticipated by the legislature, the Board shall designate a higher priority to the

1 project. The matter then shall be submitted to and be subject to the same approval by the
2 members of the legislature in the manner previously indicated in this Section. If such
3 approval is granted, notification by the chair or secretary of the board of the change of
4 priority shall be transmitted to the State Bond Commission, which then upon request of the
5 commissioner of administration, may proceed with the sale of general obligation bonds or
6 the granting of cash lines of credit in accordance with the general rule. As to projects within
7 a priority, the State Bond Commission acting on requests submitted by the commissioner of
8 administration shall determine when such project, or phases thereof, shall be funded. In
9 making such determination, the State Bond Commission shall consider the amount of
10 proceeds of general obligation bonds to be made available in light of money and capital
11 market conditions; the expenditure requirements of the project; the time required for
12 architectural plans and drawings, public bidding, and site acquisition and preparation;
13 availability of receipt of federal monies; litigation affecting the undertaking or completion
14 of a project; federal tax laws and regulations regarding the sale of municipal bonds; and
15 other items of a similar nature bearing upon the possibility or the necessity to commence a
16 project or any particular phase thereof.

17 Any other provision of this Act to the contrary notwithstanding, projects described
18 in Priority 5 of this Act shall not be moved to a higher priority except upon one of the
19 following conditions: (1) Funding is necessary to complete or additionally fund a project
20 located elsewhere in the Capital Outlay Act. Determination of such condition shall be made
21 by the head of the appropriate department or agency by means of a certificate to that effect
22 filed with the Interim Emergency Board, who shall, by mail ballot, request approval of such
23 change and if approved by a majority of each house of the legislature it shall be funded, or
24 (2) unless required by an emergency or other cause not reasonably anticipated by the
25 legislature, to be in accordance with procedures set forth in this Section. However, the State
26 Bond Commission may authorize a non-cash line of credit for any project in Priority 5 which
27 represents that portion of construction contracts which were let during a previous fiscal year,
28 or construction contracts which will be let during the current fiscal year, but which will not
29 require cash expenditures during the year. Such non-cash lines of credit, when combined

1 with previously sold bonds or with higher priority bonds or lines of credit, or with funds
2 appropriated from other sources, will provide sufficient appropriated funds to award
3 equipment or construction contracts. Contracts shall not be awarded without approval of the
4 division of administration.

5 Upon approval by the State Bond Commission, and subject to compliance with its
6 policies and procedures and the procedures set forth herein, a line of credit providing for the
7 use of funds in anticipation of the sale of general obligation bonds may be granted to the
8 appropriate administering agency or department from the Comprehensive Capital Outlay
9 Escrow Account, or if there is not a sufficient amount available in such account, from other
10 available state cash in the state treasury, for capital improvement projects for which bond
11 proceeds are appropriated by a current capital budget, prior to the actual issuance of bonds
12 for such projects, unless the attorney general advises that an impediment exists to the valid
13 issuance of the bonds on the date such line of credit is granted.

14 All bonds that are to be repaid, in whole or in part, by revenues generated by the
15 project shall be designated as "Reimbursement Bonds". The State Bond Commission shall
16 enter into such agreements as are necessary to provide that the agency or subdivision, whose
17 project is reimbursable, shall pay the bond debt costs into the Bond Security and Redemption
18 Fund. Such costs may be paid annually or at the end of the term of the bonds issued as
19 determined by the State Bond Commission.

20 Priority 1 general obligation bond funding shall be limited to:

21 (1) Projects and amounts which were previously authorized by Act 20 of the 2019
22 Regular Session of the Legislature; and which were granted cash lines of credit by the State
23 Bond Commission. The bonds to fund these projects were not sold in Fiscal Year 2019-
24 2020.

25 (2) The reauthorization of the portion of the outstanding Fiscal Year 2019-2020
26 Priority 5 Non-Cash Lines of Credit for projects which will require cash expenditures in
27 Fiscal Year 2020-2021 and therefore must be converted to Cash Lines of Credit in Fiscal
28 Year 2020-2021.

1 (3) Commitments made in the Higher Education Desegregation Settlement
2 Agreement.

3 Priority 2 general obligation bond projects are for the completion of plans and
4 specifications, land acquisition, site preparation, or for construction which will begin during
5 the fiscal year. It is presently anticipated that the listed projects will require the sale of
6 bonds or extension of lines of credit during the fiscal year after adoption of this Act.

7 Priority 3 general obligation bond projects are for the preparation of plans and
8 specifications, land acquisition, site preparation, or for construction and shall be limited to
9 funding for the portion of construction contracts which will not require cash expenditures
10 during the fiscal year. The projects in this category shall be considered future year projects
11 in the state's five-year capital outlay plan. It is presently anticipated that the listed projects
12 will not require the sale of bonds or extension of lines of credit during the fiscal year.

13 Priority 4 general obligation bond projects are for the preparation of plans and
14 specifications, land acquisition, site preparation, or for construction and shall be limited to
15 funding for the portion of construction contracts which will not require cash expenditures
16 during the fiscal year. The projects in this category shall be considered future year projects
17 in the state's five-year capital outlay plan. It is presently anticipated that the listed projects
18 will not require the sale of bonds or extension of lines of credit during the fiscal year.

19 Priority 5 general obligation bond funding shall be limited to funding for the portion
20 of construction contracts which will not require cash expenditures during the fiscal year.
21 These funds, when combined with previously sold bonds or with higher priority bonds on
22 lines of credit, or with funds appropriated from other sources, will provide sufficient
23 appropriated funds to award contracts. Non-cash lines of credit shall be required prior to the
24 award of these contracts.

25 In accordance with the cash management plan adopted pursuant to R.S. 48:251(D)
26 and the provisions of Act 161 of the 1998 First Extraordinary Session, the Department of
27 Transportation and Development is authorized to enter into contracts or agreements for
28 projects approved pursuant to the Highway Priority Program, Airport Construction and
29 Development Priority Program, Port Construction and Development Priority Program, and

1 Statewide Flood Control Program for projects bid and awarded, authorized, or commenced
 2 during the fiscal year which do not require cash expenditures for the full contract or
 3 agreement amount.

28 The appropriation of monies in this Section shall be deemed to be and constitute approval
29 by the Joint Legislative Committee on the Budget.

30 Section 2. The expenditure of funds appropriated in this Act, except appropriations
31 made to nonprofit economic development corporations, shall be in conformity to all existing
32 statutes relative to public bidding, contractual review, and R.S. 39:101 through 128 and any

1 other statutes affecting the capital outlay program for state government, state institutions,
2 and political entities. No contract shall be awarded for any project prior to the granting of
3 a line of credit or the sale of bonds by the State Bond Commission, determination by the
4 state treasurer that cash funding is available in the Comprehensive Capital Outlay Escrow
5 Account for the project, or delivery of revenue bonds whose issuance is authorized in
6 Section 1 of this Act.

7 Section 3. Payment for projects specified in this Act must be made by warrant
8 submitted to the division of administration, Department of Transportation and Development,
9 the state treasurer or other administering agency as provided in Section 8, whichever is
10 appropriate, only to the extent of funds required for immediate payment. Copies of invoices
11 or other supporting documentation shall be submitted with warrants. In the event that any
12 equipment included in this Act, is procured pursuant to the provisions of the State Lease-
13 Purchase Act, R.S. 39:1761 et seq., the amounts included in this Act for each such piece of
14 equipment shall not be appropriated. The provisions of R.S. 39:1771 which require
15 equipment to be leased under the State Lease-Purchase Act to be included in the executive
16 budget and approved by the legislature through inclusion in the General Appropriation Act
17 shall be considered waived upon the inclusion of such equipment in this Act. Projects
18 contained in this Act may, at the direction of the division of administration and with the
19 approval of the State Bond Commission, alternatively be funded through financing programs
20 heretofore or hereafter provided by a public trust and public corporation duly organized
21 pursuant to R.S. 9:2341 et seq., having for its beneficiary the state and the Louisiana Local
22 Government Environmental Facilities and Community Development Authority, pursuant to
23 R.S. 33:4548.1 et seq.

24 Section 4. If at any time during the Fiscal Year 2020-2021, the governor should find,
25 or the Joint Legislative Committee on the Budget or the commissioner of administration
26 should report to the governor, that the receipts of the treasury are falling short or appear
27 likely to fall short of the revenue estimates for the fiscal year and that a cash deficit is likely
28 to be incurred, the governor shall take such steps as deemed necessary to prevent the
29 occurrence of a cash deficit. In the event that a capital outlay project funded in this Act falls

1 under an agency which is abolished or for which funds are not appropriated in the 2020-2021
2 General Appropriation Act, then the funds appropriated in this Act for such capital outlay
3 projects shall not be expended unless deemed necessary by the governor to protect life or
4 property. In the event that legislation is enacted which transfers facilities or programs for
5 which projects are funded in this Act, on behalf of one agency, institution, department, or
6 management board to another agency, institution, department, or management board, then
7 the projects in this Act shall be deemed transferred also.

8 Section 5. All monies appropriated by this Act and any applicable funds of a prior
9 capital outlay budget act adopted by the legislature shall be deposited by the state treasurer
10 in the Comprehensive Capital Outlay Escrow Account, established by this Section, in the
11 state treasury. In accordance with R.S. 36:764, no later than sixty days following the end
12 of each quarter, the state treasurer shall report to the Joint Legislative Committee on the
13 Budget and the commissioner of administration, all funds contained in the Miscellaneous
14 Fund of the Comprehensive Capital Outlay Escrow Account. Notwithstanding any
15 provisions contained herein or other law to the contrary, any original issue premium or
16 accrued interest proceeds received pursuant to the sale of general obligation bonds shall
17 remain on deposit to the credit of the Bond Security and Redemption Fund until such time

19 promulgated pursuant to the Internal Revenue Code of 1986. All such monies shall be

26 approval of the Joint Legislative Committee on the Budget, may direct the use of interest
27 earned from the investment of general obligation bond or note proceeds in the
28 Comprehensive Capital Outlay Escrow Account, not to exceed an aggregate of five million
29 dollars in any one fiscal year, for the purpose of completing the projects contained in any

1 capital outlay budget act and such money shall be deemed appropriated in specific amounts
2 necessary for such purpose. All appropriations in this Act which are made as additions to
3 funds for previously authorized projects shall be included, for accounting purposes, in the
4 account of the previously authorized projects. If it is determined by the director of the office
5 of facility planning and control, division of administration, that it is cost effective and
6 practical to combine individual appropriations, the commissioner of administration, subject
7 to the approval of the Joint Legislative Committee on the Budget, may direct that two or
8 more appropriations or parts thereof may be combined into a single project for accounting
9 and audit purposes. The commissioner of administration may direct that funding in the
10 various statewide and/or multiple parish projects for improvements for state facilities may
11 be transferred to any project, in this Act or any previous Capital Outlay Act, which require
12 supplemental funding for improvements for state facilities which qualify for funding through
13 the various statewide and/or multiple parish projects for improvements for state facilities.
14 The office of facility planning and control, division of administration is authorized to receive
15 settlements and vendor rebates and to use a portion or all of those receipts to replace other
16 funds appropriated in this Act or any previous Capital Outlay Act including those previously
17 appropriated funds that become unavailable. Further, the office of facility planning and
18 control may add funds from settlement and/or vendor rebate receipts as new funding for any
19 projects in this Act with approval by the Joint Legislative Committee on the Budget. The
20 office of facility planning and control, division of administration is authorized to receive
21 insurance payments and are hereby authorized to immediately repair facilities that suffer
22 insurance losses without those projects being included in the Act and shall report to the Joint
23 Legislative Committee on the Budget any expenditures from insurance funds received
24 pursuant to this section. A portion, as determined by the commissioner of administration and
25 not to exceed one percent (1%), of the funding for projects which qualify for the Percent for
26 Art Program and not to exceed \$450,000 for an individual, qualifying project, may be
27 transferred from the qualifying project budgets, to the Department of Culture, Recreation and
28 Tourism for costs of acquiring art and administering the program. For all Percent for Art

1 Program projects in this or any previous capital outlay, up to ten percent (10%) of the
2 aforementioned one percent (1%) may be used for the costs of administering the projects.

3 Section 6. No later than February 1, 2021, agencies administering capital outlay
4 projects will submit reports identifying completed projects and cash balances to the Joint
5 Legislative Committee on Capital Outlay pursuant to the reporting requirements of R.S.
6 39:105 and 116.

7 Section 7. The commissioner of administration, with the approval of the Joint
8 Legislative Committee on the Budget, is authorized to supplement or substitute the
9 appropriations specified in this or previous capital outlay acts with any federal or other funds
10 which are or may become available and such funds shall be deemed appropriated in specific
11 amounts necessary for the purposes of this Act. Any funds received by the State Bond
12 Commission as a result of a prepayment of reimbursement contracts as authorized by law
13 and the policy and procedure for reimbursement contracts of the Department of Treasury,
14 office of State Bond Commission, shall be deposited as set forth in such policy and
15 procedure and shall be deemed available and appropriated in specific amounts necessary for
16 the purposes of this Act pursuant to the procedure set forth in this section.

17 Section 8.(A) All projects herein authorized and funded shall be subject to the
18 provisions of R.S. 39:101 through 128. With the exception of appropriations made to the
19 Department of Military Affairs, the Legislature, the Louisiana Stadium and Exposition
20 District, the Department of Economic Development, the Coastal Protection and Restoration
21 Authority, the Division of Administration for Supplemental State Funds for Local
22 Government Assistance Program, the Division of Administration for the Community Water
23 Enrichment Program or the Department of Transportation and Development, all funds herein
24 appropriated shall be considered as having been appropriated directly to the Office of
25 Facility Planning and Control, Division of Administration. All cooperative endeavor
26 agreements for non-state entities shall be prepared by the appropriate administering agency.

27 (1) Notwithstanding anything contained in this act to the contrary or any other
28 provision of law, the appropriations made for the Louisiana Stadium and Exposition District
29 shall be appropriated directly to the Louisiana Stadium and Exposition District, and are

1 public purposes pursuant to the provisions of Article VII, Section 14 of the Constitution of
2 Louisiana primarily for economic development, including the generation of tax revenue,
3 creation of jobs, and the generation of tourism, and may be used to reimburse any
4 expenditure made prior to the granting of a line of credit or the sale of bonds by the State
5 Bond Commission, determination by the State Treasurer that cash funding has been
6 deposited in the Comprehensive Capital Outlay Escrow Account for the project.

7 (2) Further, with respect to appropriations to the Louisiana Stadium and Exposition
8 District for the TPC Louisiana, Planning and Construction project, the Louisiana Stadium
9 and Exposition District shall be permitted to use alternative competitive procurement and
10 delivery methods for the award of any contracts to be funded through such appropriation.

11 (3) The Louisiana Stadium and Exposition District shall have the authority to
12 directly appoint a design professional from a list of a minimum of three architectural firms
13 or joint ventures with professional sports facility design experience acceptable to the
14 Commissioner of Administration and shall be exempt from other state requirements for
15 selection of designers. The design professional fee shall be in accordance with state
16 guidelines administered by the Office of Facility Planning and Control, Division of
17 Administration.

18 (B)(1)(a) Funds appropriated in the Capital Outlay Act under the name of non-state
19 entities shall be administered by the Office of Facility Planning and Control, Division of
20 Administration under cooperative endeavor agreements; however, projects involving state
21 or federal highways may be administered by the Department of Transportation and
22 Development, if appropriate. Cooperative endeavor agreements entered into pursuant
23 appropriations in this Act shall not be required to be submitted to the Division of
24 Administration, Office of State Procurement.

25 (b) Further, for all projects in the Capital Outlay Act or a previous Capital Outlay
26 Act which are appropriated to the Office of Facility Planning and Control, Division of
27 Administration, including those administered by cooperative endeavor agreements, up to six
28 percent of each line-item may be used for costs of administering the projects.

1 (c) For all projects in Capital Outlay Act or a previous Capital Outlay Act
2 appropriated to the Department of Transportation and Development, up to six percent of
3 each line-item may be used for costs of administering the projects, or for field
4 engineering/construction supervision.

5 (2) Notwithstanding anything in this Act, or a previous Capital Outlay Act, the
6 Office of Facility Planning and Control may enter into a cooperative endeavor agreement
7 with the Archdiocese of New Orleans and Jefferson Parish for the Preservation and
8 Restoration of Historic Structure for Hope Haven/Madonna Manor Campus, Planning and
9 Construction project.

10 (C) Line-item general obligation bond projects appropriated to the Department of
11 Transportation and Development in the Capital Outlay Act or a previous Capital Outlay Act
12 shall be authorized to draw Transportation Trust Funds from the Highway Program
13 appropriation, for supplemental funding on overruns in excess of the original estimated
14 project cost as determined by the Department of Transportation and Development, provided
15 however that said projects are in the state or federal highway system and in the priority
16 program, and the overrun is less than \$50,000. Any such overrun of \$50,000 or more must
17 be approved by the Joint Legislative Committee on the Budget.

18 (D) All ports, levee districts and other non-state entities must have a fully executed
19 cooperative endeavor agreement, from the administering agency or the State Treasurer,
20 whichever is appropriate, before entering into any contracts which obligate state funding and
21 must follow all laws pertaining to public bidding. If a port, levee district or other non-state
22 entity enters into a contract prior to receipt of funding, or prior to execution of a cooperative
23 endeavor agreement, then payments under such contracts are prohibited from capital outlay
24 appropriations, and are the sole responsibility of the port, levee district, or other non-state
25 entity.

1 (1) Notwithstanding anything in this Act or the Capital Outlay Act to the contrary,
2 contracts may be entered into for the City of New Orleans, Eastern New Orleans Hospital
3 and Medical Office Building, Real Estate Acquisition, Planning, Design, Construction,
4 Renovation and Equipment project prior to receipt of funding and prior to execution of the
5 cooperative endeavor agreement.

6 (2) Notwithstanding anything contained in this Act, or the Capital Outlay Act, or any
7 other capital outlay act, contracts may be entered into for the Port of South Louisiana,
8 Globalplex Rail Siding; Globalplex Terminal Building #71 Upgrade, Planning and
9 Construction and/or Administration Building (also known as the Business Development
10 Center) projects prior to receipt of funding and prior to execution of a cooperative endeavor
11 agreement.

12 (3) Notwithstanding anything in this Act or the Capital Outlay Act to the contrary
13 or any other provision of law, contracts may be entered into for the Greater Baton Rouge
14 Port Commission Inland Rivers Marine Terminal Dock and Access Roadway Construction
15 Project, Planning and Construction Project prior to receipt of funding and prior to the
16 execution of a cooperative endeavor agreement.

17 (4) Notwithstanding anything in this Act or the Capital Outlay Act to the contrary
18 or any other provision of law, contracts may be entered into for the Mississippi River Levee
19 Raising, Arkansas to Old River project prior to receipt of funding, and the State is authorized
20 to financially participate in obligations created by such contracts.

21 (5) Notwithstanding anything contained in this Capital Outlay Act, or any previous
22 Capital Outlay Act to the contrary, or any other provision of law, contracts may be entered
23 into for the Broussard, Reconstruct South Bernard Road from La. Hwy. 182 to US Highway
24 90, Planning and Construction in Lafayette Parish project, prior to execution of the
25 cooperative endeavor agreement and/or receipt of funding, and the state is authorized to
26 financially participate in obligations created by such contracts, and the right-of-ways and
27 servitudes acquired by the City are considered eligible expenses and may be used as local
28 match for the project.

1 (6) Notwithstanding anything contained in this Capital Outlay Act, or any previous
2 Capital Outlay Act to the contrary, or any other provision of law, contracts may be entered
3 into for the Westwego Fire Station, Planning and Construction in Jefferson Parish project,
4 prior to receipt of funding and the state is authorized to financially participate in obligations
5 created for such project.

6 (7) Notwithstanding anything contained in this Capital Outlay Act, or any previous
7 Capital Outlay Act to the contrary, or any other provision of law to the contrary, contracts
8 may be entered into for the full amount of the general obligation bond appropriation
9 contained in this Act for the Airport Access Road in Iberia Parish project prior to receipt of
10 funding and prior to the execution of the cooperative endeavor agreement, the State is
11 authorized to financially participate in obligations created by such contracts.

12 (8) Notwithstanding anything in this Act or the Capital Outlay Act to the contrary
13 or any other provision of law, contracts may be entered into for the Residential Capacity
14 Expansion, Acquisition for Eden House in Orleans Parish project prior to receipt of funding,
15 and the State is authorized to financially participate in obligations created by such contracts.

16 (9) Notwithstanding anything in this Act or the Capital Outlay Act to the contrary
17 or any other provision of law, contracts may be entered into for the New Sewerage and
18 Water Board Power Plant, Planning and Construction for the City of New Orleans in Orleans
19 Parish project prior to receipt of funding and the State is authorized to financially participate
20 in obligations created by such contracts.

21 (10) Notwithstanding anything in this Act or any previous Capital Outlay Acts to the
22 contrary, contracts may be entered into for the Woodlands Conservancy, Construction of
23 Restroom Facilities at Woodlands Trail, Planning and Construction (Plaquemines) prior to
24 the receipt of funding and the State is authorized to financially participate in obligations
25 created by such contracts.

26 (F) Pursuant to R.S. 39:112(E)(2), non-state entity projects shall require a match of
27 not less than twenty-five percent of the total requested amount of funding; however,

1 (1) Notwithstanding the provisions of R.S. 39:112(E)(2), the project for
2 Independence, Independence Area Community Pavilion, Planning and Construction, shall
3 be exempt from all local match requirements.

4 (2) Notwithstanding anything contained in this Act, the Capital Outlay Act, any
5 other provision of law, or the provisions of R.S. 39:112(E)(2) to the contrary, the project for
6 Lockport Street Improvements, Planning and Construction, shall be exempt from all local
7 match requirements.

8 (3) Notwithstanding anything contained in this Act, any prior Capital Outlay Act,
9 any other provision of law, or the provisions of R.S. 39:112(E)(2) to the contrary, the project
10 for the Village of Doyline Wastewater Treatment Facility shall be exempt from all local
11 match requirements.

14 for Westwego, Emergency Preparedness Building, Planning and Construction, local match
15 requirement shall be twenty-five percent of the amount appropriated by the state.

16 (5) Notwithstanding anything contained in this Act, any prior Capital Outlay Acts,
17 any other provision of law, or the provisions of R.S. 39:112(E)(2) to the contrary, the project
18 for St. James Parish, Roundabout at Intersection of LA 3125 and LA 3274, LA 22 Geometric
19 Improvements near I-10, Planning and Construction, shall be exempt from all local match
20 requirements.

21 (G) Pursuant to R.S. 39:102, each capital outlay budget request submitted as
22 required by R.S. 39:101 shall include a detailed project description and justification for each
23 new project requested; however,

24 (1) Notwithstanding anything contained in this Act or the Capital Outlay Act to the
25 contrary, or any other provision of law including the scope of the appropriations made in this
26 Capital Outlay Act or any other Capital Outlay Act for the City of New Orleans, Eastern
27 New Orleans Hospital and Medical Office Building, Real Estate Acquisition, Planning,
28 Design, Construction, Renovation and Equipment project, the City of New Orleans may
29 make such capital outlay funds available to the Parish Hospital Service District of the Parish

1 of Orleans District "A" in furtherance of the District's planning, design, acquisition,
2 development, renovation, construction, equipment and operation of a hospital and medical
3 office building in Eastern New Orleans.

4 (2) Notwithstanding anything contained in this Act or the Capital Outlay Act to the
5 contrary or any other provision of law, the scope of the appropriations made in the Capital
6 Outlay Act or any other Capital Outlay Act for the Jefferson Parish Bonnabel Canal
7 Rehabilitation and Bank Stabilization (Veterans Boulevard to West Esplanade), Planning
8 and Construction project shall be deemed to include steel sheet pile bulkhead, and/or bank
9 excavation and reshaping, bridge replacement, property acquisition, demolition and
10 improvements needed to stabilize the canal bank along the Bonnabel Drainage Canal in
11 order to address canal bank failures between Veterans Boulevard and West Esplanade
12 Avenue.

13 (3) Notwithstanding anything contained in this Act or the Capital Outlay Act to the
14 contrary or any other provision of law, The Vernon/Fort Polk Thoroughfare Electrical Power
15 Extension project shall include Utilities Including Generators.

16 (4) Notwithstanding anything in this Act, the Capital Outlay Act, any previous
17 capital outlay act, or other provision of law to the contrary, the scope of the appropriation
18 for the Port of South Louisiana Globalplex Terminal Building #71 Upgrade project shall be
19 deemed to also include similar upgrades for other Globalplex Terminal Buildings and a
20 Heavy Load Capacity Foundation or Floor.

21 (5) Notwithstanding anything contained in this Act, the Capital Outlay Act, or any
22 other provision of law to the contrary, the scope of the appropriation for the Department of
23 Transportation and Development, LA 22 Improvements (LA 16 to Diversion Canal),
24 Planning and Construction (Livingston) is deemed to also include the overlay of LA 22 from
25 Head of Island to Chinquapin Bridge.

26 (6) Notwithstanding anything contained in the Act or a previous Capital Outlay Act,
27 any provision of law, or in any cooperative endeavor agreement between the Office of
28 Facility Planning and Control and Westwego, the scope of the appropriations in this or any

1 previous Capital Outlay Act for Westwego, The WHARF project shall be deemed to include
2 site preparation.

3 (7) Notwithstanding anything contained in the Act or the Capital Outlay Act to the
4 contrary or any other provision of law, the Slip Dredging and Improvements for the
5 Terrebonne Port Commission Government Multi-Use Complex, Planning and Construction
6 project shall be deemed to include Houma Navigation Canal Dredging.

7 (8) Notwithstanding anything contained in this Act or a previous Capital Outlay Act,
8 any provision of law, or in any cooperative endeavor agreement between the Office of
9 Facility Planning and Control and the Pontchartrain Levee District, the scope of the
10 appropriations in this or any previous Capital Outlay Act for the Pontchartrain Levee
11 District, East St. Charles Urban Flood Control project shall be deemed to include planning,
12 design, and construction of the East St. Charles Urban Flood Control project, including the
13 Almedia, St. Rose, and Airport Pump Stations located in the eastern end of the East Bank
14 of St. Charles Parish.

15 (9) Notwithstanding anything contained in this Act, the Capital Outlay Act, or any
16 other Capital Outlay Act, the scope of the appropriation for the Department of
17 Transportation and Development, Jimmie Davis Bridge Rehabilitation and Lighting,
18 Planning and Construction project in Bossier and Caddo parishes, shall be deemed to include
19 the planning, design and construction of a new bridge.

20 (10) Notwithstanding anything contained in this Act or any other Capital Outlay Act,
21 the scope of the appropriation for the False River Ecosystem Restoration Project, Planning
22 and Construction project in Pointe Coupee Parish shall be deemed to include bulkhead
23 replacement.

24 (11) Notwithstanding anything contained in this Act, or any prior Capital Outlay
25 Act, the scope of the appropriation for the Lake Pontchartrain West Shore Hurricane
26 Protection Project, Planning and Construction project in multiple parishes shall be deemed
27 to include West Shore Enhancements.

28 (12) Notwithstanding anything contained in this Act, or any prior Capital Outlay
29 Act, the scope of the appropriation for the Water Tower, Line and Improvements, Water

1 Meter Replacement, Planning and Construction project in Westwego shall be deemed to
2 include Water Meter replacements.

3 (13) Notwithstanding anything contained in this Act or any other Capital Outlay Act,
4 the scope of the appropriation for the LA 42 (US 61 to LA 44) Widening project in
5 Ascension Parish shall be deemed to include the Roundabout on LA 42 at Joe Sevario Road,
6 Planning and Construction.

7 (14) Notwithstanding anything in this Act or any previous Capital Outlay Acts to the
8 contrary the project for Tallulah, Improvements to Sewer System, Planning and Construction
9 (Madison) and the project for Tallulah, Sewer Treatment Plant Improvements City of
10 Tallulah (Madison) shall be deemed to be a single project for Tallulah, Improvements to
11 Sewer System including Sewer Treatment Plant Improvements, Planning and Construction.

12 (15) Notwithstanding anything in this Act, the Capital Outlay Act, any previous
13 capital outlay act, or other provision of law to the contrary, the scope of the appropriation
14 for the Port of South Louisiana Globalplex Dock Access Bridge and Equipment
15 Replacement/Repair project shall be deemed to also include an Access Road.

16 (16) Notwithstanding anything contained in this Act or the Capital Outlay Act to the
17 contrary or any other provision of law, the scope of the appropriations made in this or any
18 other Capital Outlay Act for the New Orleans West Bank Park Improvements, New Soccer
19 and Recreational Facilities, and Skateboard Park project and the Norman Playground
20 Basketball Gym, Planning and Construction project shall be deemed to include the George
21 W. Carver Playground, Renovations and Upgrades project for the West Bank Park project
22 and park enhancements for a walking track, basketball, football, and baseball fields and a
23 concession stand for the Norman Playground project.

24 (17) Notwithstanding anything in this Act, the Capital Outlay Act, any previous
25 capital outlay act, or other provision of law to the contrary, the scope of the appropriation
26 for the Jean Lafitte Wetlands Museum Addition, Planning and Construction project in
27 Jefferson Parish shall be deemed to also include additional square footage to accommodate
28 a bigger museum building.

1 (18) Notwithstanding anything in this Act, the Capital Outlay Act, any previous
2 capital outlay act, or other provision of law to the contrary, the scope of the appropriation
3 for the Port of South Louisiana Globalplex Rail Siding project shall be deemed to also
4 include a Rail Spur.

5 (H) Notwithstanding anything contained in this Act or the Capital Outlay Act, or in
6 any cooperative endeavor agreement between the Office of Facility Planning and Control
7 and the City of New Orleans or the Hospital Service District to the contrary, the Hospital
8 Service District may mortgage or otherwise encumber any and all land, real estate property,
9 including buildings and equipment, and appurtenances acquired, in whole or part, with state
10 capital outlay funds provided that bond counsel to the state opines that such mortgage shall
11 not affect the tax-exempt status of the bonds to be issued by the state for the project.

12 (I) Notwithstanding anything contained in this Act or the Capital Outlay Act to the
13 contrary or any other provision of law, the Parish Road Improvements Project for Franklin
14 Parish is exempt from the contract limit set forth in R.S. 38:2212.

15 (J) Notwithstanding anything contained in this Act or the Capital Outlay Act to the
16 contrary or any other Act or provision of law, the appropriations made for the Executive
17 Department for facilities which promote economic development included in the Repair,
18 Restoration, and Replacement for Hurricanes Katrina and Rita project, and the Department
19 of Economic Development projects are for public purposes pursuant to the provisions of
20 Article VII, Section 14 of the Constitution of Louisiana primarily for economic
21 development, including the generation of tax revenues, creation of jobs, promotion of
22 tourism, and creation of facilities for charitable, cultural, artistic, educational, social, civic,
23 research, service, economic development activities, or provide facilities for professional golf
24 events, pursuant to the terms of cooperative endeavor agreements, including leases and all
25 expenditures of these appropriations and may be exempted, by the Commissioner of
26 Administration, from all statutes relative to public bidding, contractual review and the
27 provisions of R.S. 33:9029.2(D) and in lieu thereof be allowed to use alternative competitive

23 be used to reimburse any expenditure made prior to the granting of a line of credit and made
24 prior to the execution of a cooperative endeavor agreement and shall be administered solely
25 by the Department of Economic Development pursuant to, in compliance with, and on the
26 terms contained in such cooperative endeavor agreements without compliance with any other
27 law, including, but not limited to, the provisions of R.S. 39:101 through 128. Additionally,
28 all expenditures of these appropriations may be exempted by the Commissioner of

1 Administration, from all statutes relative to public bidding, contractual review and the
2 provisions of R.S. 33:9029.2(D).

3 (L)(1) Notwithstanding any other provision of this Act or the Capital Outlay Act or
4 any other provision of law to the contrary, funds appropriated for the Economic
5 Development Award Program project for the Office of Business Development are to be used
6 solely for capital and infrastructure improvements subject to verification by the Division of
7 Administration, Office of Facility Planning and Control.

8 (2) Eligible expenses for Economic Development Award Program funds may include
9 documented project expenses beginning on the date of LEDC Board approval of the project
10 and may be reimbursed upon execution of the cooperative endeavor agreement for the
11 project.

12 (M) Notwithstanding anything in this Act, any previous capital outlay act, or other
13 provision of law to the contrary, monies appropriated herein for the Port of South Louisiana
14 Globalplex Terminal Building #71 and Other Globalplex Terminal Building Upgrades,
15 Planning and Construction may be expended for design fees related to the conveyor system
16 and ancillary equipment that exceed the customary ten percent limitation on design fee costs.

17 (N) Notwithstanding anything in this Act to the contrary or any other provision of
18 law, monies appropriated herein for the Juban Road (LA 1026) Widening (I-12 to US 190)
19 project may be expended for the installation of sewer lines along the roadway and pursuant
20 to a cooperative endeavor agreement between the Department of Transportation and
21 Development and Livingston Parish, funds may be provided to Livingston Parish for that
22 purpose.

23 (O)(1) Due to the state's current investment in TPC Louisiana and the financial
24 support it provides to the PGA TOUR event currently played at said facility, said PGA
25 TOUR event shall not be played at New Orleans City Park Golf Complex without the prior
26 agreement of the Commissioner of Administration and the Chairman of the Jefferson Parish
27 Council.

1 (2) Notwithstanding the foregoing, the City Park Golf Complex may host any other
2 golf tournament or event, including but not limited to any other PGA-affiliated or sponsored
3 tournament or event.

4 (P)(1) For all projects administered by the Office of Facility Planning and Control
5 and payable from proceeds of self-generated revenues, funds shall be remitted to the Office
6 of Facility Planning and Control for deposit in the state treasury at such time as may be
7 deemed necessary by the Office of Facility Planning and Control in order to cover the
8 amount of contracts or other project expenses.

9 (2) Notwithstanding any provisions contained herein or any other law to the
10 contrary, for projects with other means of financing provided to the administering agency
11 by interagency transfer, the authority to draw these funds shall remain with the user agency.

12 (3) Any revenue bonds appropriated in Section 1 of the Capital Outlay Act shall not
13 be secured by the full faith and credit of the state.

14 (4) The State Treasurer shall refund to the appropriate source any surplus self-
15 generated funds, advanced insurance funds received by the Office of Facility Planning and
16 Control as Interagency Transfer from Office of Risk Management associated with hurricane
17 damage recovery, and interest earned on these funds, provided the Treasurer's Office is
18 notified, when these funds are deposited in the state treasury, that the user agency or Office
19 of Risk Management intends to request a refund of this interest.

20 (Q) Notwithstanding anything contained in this Act, the Capital Outlay Act, or any
21 other provision of law to the contrary, the Department of Transportation and Development
22 shall use \$2,500,000 of general obligation bond funding appropriated for Department of
23 Transportation and Development, Administration, Highway Program (Up to \$4,000,000 for
24 Secretary's Emergency Fund) in Act 25 of the 2014 Regular Session of the Legislature for
25 the Louisiana Highway 92 Overlay, Preservation and Construction (Lafayette) project.

26 (R) Notwithstanding any provisions contained in this Act, the Capital Outlay Act,
27 or any other provision of law to the contrary, any funds expended by the parish of St. Mary
28 for the purpose of securing a federal grant, for the Infrastructure Improvements and

1 Construction of a Welding Training Center Facility at the Charenton Canal Industrial Park,
2 shall be eligible for reimbursement from any cash line of credit approved for the project.

3 (S) Notwithstanding anything contained in this Act to the contrary or any other
4 provision of law, the resolution adopted by the Joint Legislative Committee on the Budget
5 (the committee) on March 19, 2019 approving State of Louisiana Grant Anticipation
6 Revenue Bonds, in one or more series, not exceeding \$650,000,000, and approving the
7 related projects and providing for other matters in connection therewith, contains the
8 following approvals:

9 (1) The first series of bonds in the original principal amount of not exceeding
10 \$185,000,000 in order to fund the following projects in the following estimated amounts:
11 Barksdale Project (\$61,600,000) and portions of the Loyola Project (\$77,600,000) and the
12 I-10 Project (\$30,601,000) with the understanding that the Department has the ability to
13 manage the actual application of bond proceeds in order to appropriately fund the Projects
14 and meet expenditure requirements of the Internal Revenue Service.

15 (2) The second series of bonds for the express purpose of granting the required
16 contracts in the principal amount of approximately \$142,000,000 in order to fund the
17 following projects in the following estimated amounts: the balance of the Barksdale Project
18 (\$16,518,000), the balance of the Loyola Project (\$87,500,000), portions of the I-10 Project
19 (\$37,982,000) and the Belle Chasse Project (\$12,500,000) with the understanding that the
20 Department has the ability to manage the actual application of Bond proceeds in order to
21 appropriately fund the Projects and meet expenditure requirements of the Internal Revenue
22 Service provided, however, the Department of Transportation and Development seeks
23 approval from the Committee for the issuance of the second series of bonds and all
24 subsequent series of bonds.

25 (T) Notwithstanding anything contained in this Act to the contrary or any other
26 provision of law, the appropriations included herein identified as "Payable from State
27 General Fund (Direct) Non-Recurring Revenues" are appropriated for the purpose of
28 making supplemental capital outlay appropriations for Fiscal Year 2019-2020.

1 (U) Notwithstanding anything contained in this Act to the contrary or any other
2 provision of law, the Research Vessel (R/V) Pelican Replacement is deemed to be a capital
3 asset and the appropriation to Louisiana Universities Marine Consortium (LUMCON) to
4 replace the R/V Pelican is for a public purpose and has a significant economic impact
5 providing a variety of oceanographic research missions. Further, LUMCON shall be
6 permitted to use an alternative delivery method to award contracts for design of the proposed
7 replacement vessel. LUMCON shall have the authority to select the design professional
8 from a list of a minimum of two engineering firms or joint ventures with ship design
9 experience acceptable to the Commissioner of Administration and the selection shall be
10 exempt from other state requirements for the selection of designers. The design professional
11 fee shall be in accordance with state guidelines administered by the Office of Facility
12 Planning and Control, Division of Administration. LUMCON shall follow the public bid
13 law for the procurement of the replacement vessel.

14 (V) Notwithstanding anything contained in this Act to the contrary or any other
15 provision of law, the appropriations for Major Repairs for Higher Education Facilities -
16 Infrastructure, and Buildings Based on Statewide Condition Assessment, Planning and
17 Construction, in Act 7 of 2008 identifying specific projects for higher education is deemed
18 to be complete, and any remaining residual funds are hereby authorized to be combined and
19 accumulated to accomplish additional major repair projects within the higher education
20 systems, as deemed necessary and approved by the Board of Regents and Facility Planning
21 and Control.

22 (W) Notwithstanding anything contained in this Act or any other provision of law,
23 LSU Real Estate and Facilities Foundation (LRFF) is authorized to execute contracts for the
24 University Lakes Restoration Project to Address Flood Control, Environmental, Safety,
25 Health and Other Issues project prior to execution of a cooperative endeavor agreement, the
26 granting of a line of credit or the sale of bonds. The appropriation for this project may be
27 used to pay any obligation incurred or to reimburse any expenditure made pursuant to such
28 contracts unless the Commissioner of Administration is advised by bond counsel to the state
29 that such may violate federal tax law, after execution of a cooperative endeavor agreement.

1 Further, LRFF may use alternative competitive contracting arrangements with the prior
2 approval of the Commissioner of Administration.

3 (X) Notwithstanding the provisions of R.S. 39:101, 102, and 112(C), the Evangeline
4 Parish Police Jury Overlay of US 167, from Turkey Creek North to I-49, Planning and
5 Construction project for Evangeline Parish which did not submit a capital outlay application
6 by November 1, 2019, in compliance with the provisions of R.S. 39:101, and 102, is hereby
7 deemed to have complied with the late approval requirements of R.S. 39:112(C).
8 Additionally, the capital outlay budget request together with supporting information and
9 documents for this project shall constitute the feasibility study required by Article VI,
10 Section 11(C) of the Constitution of Louisiana.

11 Section 9. Notwithstanding any provisions contained herein or any other law to the
12 contrary, the provisions of Chapter 16 of Subtitle III of Title 39 of the Louisiana Revised
13 Statutes of 1950 as amended, shall not apply to architectural and engineering contracts,
14 administered by the office of facility planning and control, division of administration
15 pursuant to this or any other capital outlay act.

16 Section 10. All funds appropriated herein to the office of facility planning and
17 control, division of administration, on behalf of non-state entities, and administered by
18 cooperative endeavor agreements pursuant to this Act shall be expended within two (2) years
19 from the date of the issuance of the bonds. The office of facility planning and control,
20 division of administration, agrees that it will notify the non-state entity of the date the bonds
21 are issued within three (3) months from the issuance thereof. The non-state entity
22 understands and agrees that if the funds appropriated herein and administered under
23 cooperative endeavor agreements pursuant to this Act are not totally expended within two
24 (2) years from the issuance of the bonds, the office of facility planning and control, division
25 of administration, can close the project and recommend that the reallocation of any
26 unexpended proceeds to any project contained in this Act or any previous Capital Outlay
27 Acts.

28 Section 11. Notwithstanding any provisions contained herein or law to the contrary,
29 the proceeds of revenue bonds to be utilized to fund certain projects authorized in Section

1 1 hereof may, in accordance with Article VII, Section 9 of the Louisiana Constitution of
2 1974, be deposited in special accounts held outside the state treasury in accordance with the
3 provisions of any bond resolution, indenture, reimbursement contract, or other bond or
4 financing covenant which provides for the pledge of such funds in connection with the
5 issuance of revenue bonds. For all projects administered by the office of facility planning
6 and control, division of administration, authorized in Section 1 hereof which are payable
7 from the proceeds of revenue bonds, only the office of facility planning and control, division
8 of administration, will be authorized to requisition funds from the special accounts described
9 immediately above, at such time or times as may be deemed necessary by the office of
10 facility planning and control, division of administration, in order to cover contract amounts
11 or other project expenses.

12 Section 12. The governor shall have the power to veto any line-item in this Act.

13 Section 13. Except as otherwise provided herein, no funds shall be expended on any
14 highway projects on highways within the state highway system as established in R.S. 48:191
15 under the jurisdiction of the Department of Transportation and Development unless and until
16 such project is in the Highway Program, R.S. 48:228 through 232, approved by the Joint
17 Legislative Committee on Transportation, Highways and Public Works. Pursuant to R.S.
18 49:214.6.2(B), no integrated coastal protection construction project shall be undertaken with
19 funds included in this bill except those included in an annual plan finally approved by the
20 legislature in accordance with the provisions of R.S. 49:214.5.3. No funds appropriated to
21 the Coastal Protection and Restoration Authority in this Act as a contribution for a project
22 cost-share or otherwise, for the national economic development and national ecosystem
23 restoration components of the Southwest Coastal Louisiana Study shall be used or provided
24 for the expropriation of property or use of eminent domain, except where such funds are to
25 be used to obtain property voluntarily offered for project purposes, where at least seventy-
26 five percent of the owners have voluntarily offered the property, or where the record or
27 apparent owners have voluntarily offered the property but do not have clear title.

28 Section 14. The word "statewide" used in place of the specific parish designation for
29 projects contained in this Act indicates that the project or program is applicable to all sixty-

1 four parishes in the state. The description of any project in this Act shall be deemed to
2 include planning, design, master planning, studies, permits, surveys, testing, construction,
3 land and/or building/improvement acquisition, reconstruction, renovation, repair, right of
4 way and utilities, site and other improvements, miscellaneous/contingencies, lease hold
5 improvements ultimately owned by the state or a political subdivision of the state, equipment
6 and other acquisitions, and any other component of the project if such are included or
7 indicated in the capital outlay request for such projects required by R. S. 39:101 subject to
8 the provisions of Title 39 of the Louisiana Revised Statutes of 1950. For new construction
9 or renovation projects, equipment or other acquisitions, which can reasonably be considered
10 necessary for the facility to be functional, may be deemed to be included in the project, even
11 if such equipment or other acquisitions are not included or indicated in the project name or
12 the capital outlay request. When local or federal match is referenced in a project title, but
13 only a portion of the state appropriation is granted a line of credit or otherwise funded, then
14 the amount of local or federal match, required to be made available, may be prorated relative
15 to the amount of state appropriation made available through lines of credit.

16 Section 15. The provisions, items, and projects contained in this Act are severable
17 and if any provision, item, or project contained herein, or the application of any such
18 provision, item, or project, is held invalid, such invalidity shall not affect other provisions,
19 items, projects, or applications of the Act which can be given effect without the invalid
20 provision, project, item, or application.

21 Section 16. Notwithstanding any other provisions of law to the contrary, the state
22 shall not grant cash lines of credit, or authorize or issue general obligation bonds in a
23 principal amount in excess of \$881,402,800 for Fiscal Year 2020-2021.

24 Section 17. Notwithstanding any contrary provision of this Act or any contrary
25 provision of law, no funds appropriated by this Act shall be released or provided to any
26 recipient of an appropriation made in this Act if, when, and for as long as, the recipient fails
27 or refuses to comply with the provisions of R.S. 24:513. No recipient shall be considered
28 to fail or refuse to comply with the provisions of R.S. 24:513 pursuant to this Section during
29 any extension of time granted by the legislative auditor to the recipient to comply.

1 Section 18. This Act shall become effective upon signature by the governor or, if not
2 signed by the governor, upon expiration of the time for bills to become law without signature
3 by the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If
4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
5 effective on the day following such approval.
