In any action to recover damages arising out of the ownership, common 12 maintenance, or operation of a motor vehicle, failure to wear a safety belt in violation of this Section shall not be considered evidence of comparative negligence. 13 14 Failure to wear a safety belt in violation of this Section shall not be admitted to 15 mitigate damages. (1) In any action to recover damages arising out of the ownership, common maintenance, or operation of a motor vehicle, failure to 16 wear a safety belt in violation of this Section may be considered evidence of 17 18 comparative negligence, except when the tortfeaser is found to have been a 19 distracted driver, or charged with a violation of R.S. 14:98 or an ordinance of 20 a political subdivision prohibiting operation of any vehicle or means of 21 transportation or conveyance while intoxicated, impaired, or while under the 22 influence of alcohol, drugs, or any controlled dangerous substance.

(2) If a party proves by a preponderance of the evidence that the injured person failed to wear a safety belt in violation of this Section at the time the injury occurred, any damages awarded to that person shall be reduced by ten percent of the total damages awarded to that person.
