TAX CREDITS: Establishes an income or corporation franchise tax credit for certain broadband coverage providers (Item #31)

AN ACT

2 To enact R.S. 47:6041, relative to income or corporation franchise tax credits; to establish 3 a tax credit for certain broadband coverage providers; to provide for the amount of 4 the credit; to limit the total amount of credits authorized to be granted; to provide for 5 requirements and limitations; to provide for an effective date; and to provide for 6 related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. R.S. 47:6041 is hereby enacted to read as follows: 9 §6041. Tax credits for broadband coverage providers in rural underserved areas of 10 Louisiana 11 A. There shall be allowed a credit against any Louisiana income or 12 corporation franchise tax for carriers participating in the Rural Digital Opportunity 13 Fund Auction, hereinafter "federal program", conducted by the Federal 14 Communications Commission to distribute fixed and mobile broadband networks to 15 eligible rural underserved areas in Louisiana. In order to be eligible for the credit 16 established pursuant to the provisions of this Section, the tax credit applicant shall 17 be a winning bidder and awarded a census block by the Federal Communications Commission and shall be in compliance with all of the rules and regulations required 18 19 pursuant to the federal program. The tax credit shall be earned by the applicant at 20 the time the broadband network is provided to the structure.

1	B.(1) The amount of the credit shall equal five hundred dollars per structure
2	in which the carrier provides a fixed or mobile broadband network that meets the
3	maximum performance tier capabilities provided for in the federal program. For
4	purposes of this Section, "structure" shall mean any business or household identified
5	in the census block pursuant to the federal program as unserved.
6	(2) A taxpayer may claim tax credits authorized pursuant to the provisions
7	of this Section to offset up to fifty percent of the taxpayer's Louisiana income or
8	corporation franchise tax liability in any one year. Unused amounts of the tax credit
9	may be carried forward as a tax credit against subsequent Louisiana income or
10	corporation franchise tax liability for a period not to exceed ten years.
11	(3) The total amount of credits that may be granted pursuant to the
12	provisions of this Section shall not exceed fifty million dollars. Credits shall be paid
13	on a first-come, first-served basis and all credits received on the last day in which the
14	maximum amount of credits are received shall be reduced on a pro rata basis so as
15	not to exceed the maximum amount of credits authorized to be granted.
16	Section 2. This Act shall become effective on July 1, 2020; if vetoed by the governor
17	and subsequently approved by the legislature, this Act shall become effective on July 1,
18	2020, or on the day following such approval by the legislature, whichever is later.

Abstract: Establishes a \$500 per structure income or franchise tax credit for carriers participating in the Rural Digital Opportunity Fund Auction to provide broadband network capabilities to eligible rural underserved areas in this state.

<u>Proposed law</u> establishes an income or corporation franchise tax credit for carriers participating in the Rural Digital Opportunity Fund Auction (federal program) conducted by the Federal Communications Commission (FCC) to distribute fixed and mobile broadband networks to eligible rural underserved areas in this state. The tax credit shall be earned at the time the broadband network is provided to the structure. <u>Proposed law</u> defines a "structure" as any business or household identified in the federal program as unserved.

<u>Proposed law</u> requires applicants for the tax credit to be winning bidders and awarded a census block by the FCC and to be in compliance with all of the rules and regulations required pursuant to the federal program.

<u>Proposed law</u> establishes the amount of the credit at \$500 per structure in which the carrier provides a fixed or mobile broadband network that meets the maximum performance tier capabilities provided for in the federal program. <u>Proposed law</u> authorizes a taxpayer to claim tax credits to offset up to 50% of the taxpayer's tax liability in any one year. Unused amounts of the tax credit may be carried forward as a tax credit against subsequent La. income or corporation franchise tax liability for a period not to exceed 10 years.

<u>Proposed law</u> limits the total amount of credits that may be granted to no more than \$50M. Credits shall be paid on a first-come, first-served basis and all credits received on the last day in which the maximum amount of credits are received shall be reduced on a pro rata basis so as not to exceed the maximum amount of credits authorized to be granted.

Effective July 1, 2020.
