7	Section 1. R.S. 13:312(3)(b)(ii) is hereby amended and reenacted to read as follows:

26	Section 2. The judgeship designated on the effective date of this Act as division "C"
27	of the second district of the Third Circuit Court of Appeal shall be assigned to election
28	section one for election purposes and the judgeships designated on the effective date of this
29	Act as divisions "A" and "B" of the second district of the Third Circuit Court of Appeal shall
30	be assigned to election section two for election purposes.

Section 3.(A) The precincts referenced in this Act are those contained in the file named "2018 Precinct Shapefiles" published on the Louisiana House of Representatives website. The 2018 Precinct Shapefiles are based upon those Voting Districts (VTDs) contained in the 2010 Census Redistricting TIGER/Line Shapefiles for the state of Louisiana as those files have been modified by the staff of the Legislature of Louisiana to represent precinct changes submitted through July 3, 2018, to the Legislature of Louisiana by parish governing authorities pursuant to the provisions of R.S. 18:532 and 532.1.

8 (B) When a precinct referenced in this Act has been subdivided by action of the 9 parish governing authority on a nongeographic basis or subdivided by action of the parish 10 governing authority on a geographic basis in accordance with the provisions of R.S. 11 18:532.1, the enumeration in this Act of the general precinct designation shall include all 12 nongeographic and all geographic subdivisions thereof, however such subdivisions may be 13 designated. The territorial limits of the election sections as provided in this Act shall 14 continue in effect without change regardless of any changes made to the precincts by the 15 parish governing authority.

Section 4. This Act shall become effective upon signature by the governor or, if not
signed by the governor, upon expiration of the time for bills to become law without signature
by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
vetoed by the governor and subsequently approved by the legislature, this Act shall become
effective on the day following such approval.
