9	§2759. Cooperative endeavor agreements authorizing payments in lieu of ad

12	(6) Prior to a participating taxing authority executing a cooperative endeavor
13	agreement for a payment in lieu of taxes, the cooperative endeavor agreement shall
14	be approved by the following: Prior to executing a cooperative endeavor
15	agreement for a payment in lieu of taxes, each taxing authority that is
16	participating in the cooperative endeavor agreement shall evidence its approval
17	in the following manner:

1	(a) The parish governing authority representing the parish and all parish
2	taxing authorities located outside the boundary of any municipality that receives a

6	municipal taxing authorities that receive a millage, evidenced by a resolution.

<u>Present act</u> language provides the method of approval applicable to each type of taxing authority that agrees to participate in a cooperative endeavor agreement.

<u>Proposed law</u> clarifies that only participating taxing authorities must approve the cooperative endeavor agreement and provides for the method of approval.

Effective if and when Senate Bill No. 396 of the 2020 R.S. is enacted and becomes effective.
