2	To commend Mark West, upon the occasion of his retirement, for thirty-six years of
3	dedicated public service to Ascension Parish and the state of Louisiana.
4	WHEREAS, Mark West began his career in tax collection in 1984 as a sales tax
5	auditor and senior agent for the Louisiana Department of Revenue; and
6	WHEREAS, Mark transitioned to local sales tax collection, becoming sales tax
7	administrator for the Ascension Parish Sales and Use Tax Authority, in 1990; and
8	WHEREAS, Mark faithfully served the people of Ascension Parish in that capacity
9	for twenty-seven years, implementing innovative programs to promote reliability and
10	efficiency in local sales tax collection; and
11	WHEREAS, during his tenure as Ascension Parish sales tax administrator, Mark was
12	a proud and active member of the Louisiana Association of Tax Administrators (LATA),
13	serving as its president in 1999 and 2012; and
14	WHEREAS, Mark retired from his position as sales tax administrator in 2017 and
15	joined LATA as its legislative director; and
16	WHEREAS, on January 1, 2018, Mark became the executive director of LATA, an
17	organization created in 1966 to assist local tax administrators, provide continuing education
18	and disseminate information, increase efficiency in local tax collection, and encourage
19	cooperation between tax administrators; and
20	WHEREAS, Mark's efforts throughout his career have fostered significant
21	developments in local sales tax collection, including the single parish collector system, the
