6	WHEREAS, Firmin's love of sports developed early in his life; he also found
7	inspiration in the Catholic education he received at Holy Cross High School, from which he
8	graduated in 1946; and
9	WHEREAS, at the age of seventeen, Firmin began coaching and discovered how
10	sports could help kids learn valuable life lessons; he made sure that all of his teams
11	understood that God came first, teammates second, and self last; and
12	WHEREAS, Firmin was a member of the Louisiana National Guard and worked as
13	a foreman for Bell South for thirty-seven years; he was also a coach and supervisor for the
14	New Orleans Recreation Department for many years; and
15	WHEREAS, during his youth sports coaching career, Firmin received numerous
16	awards; he was the recipient of the Louisiana Association of Basketball Coaches' "Mr.
17	Louisiana Basketball" award in 2007; he was also a highly decorated Babe Ruth Baseball
18	League coach for forty-six years, coaching with the New Orleans Recreation Department and
19	the Jefferson Parish Recreation Department Westbank and securing five championships; he
20	also served as the national director of Biddy Basketball for the last twenty-four years; and
