1	AN ACT
2	To amend and reenact Part II of Chapter 2 of Title 24 of the Louisiana Revised Statutes of
3	1950, comprised of R.S. 24:101 through 109, relative to state government; to create
4	the Streamlining Government Commission; to provide for the membership, powers,
5	duties, and functions of the commission; to provide for recommendations of the
6	commission; to provide procedures and deadlines for reporting; and to provide for
7	related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Part II of Chapter 2 of Title 24 of the Louisiana Revised Statutes of 1950,
10	comprised of R.S. 24:101 through 109, is hereby amended and reenacted to read as follows:
11	PART II. STREAMLINING GOVERNMENT
12	§101. Purpose and findings
13	A. The state of Louisiana faces a severe decline in revenues through fiscal
14	year 2012 which, if no corrective action is taken, will leave a significant funding gap
15	in state government expenditures and will create serious sustainability issues in the
16	financing of state obligations. The COVID-19 pandemic has resulted in severe
17	declines in revenue for both private and public sector entities and, if no action
18	is taken, the state of Louisiana will face significant funding challenges
19	threatening the ability to finance state obligations.
20	B. It is essential that the state act now to reduce the cost of state government,
21	through all means available, including efficiencies, economies, greater effectiveness,
22	and other means to streamline government in order to overcome the projected severe
23	revenue reductions occurring through 2012 and to ensure that available state tax
24	dollars are being spent efficiently and effectively. Many state agencies were created
25	over thirty years ago and a review of each agency and its activities, functions,
26	programs, and services is needed to determine whether the purpose served by the
07	agency or activity, function, program, or service continues to be relevant. Like

8	Commission on Streamlining Government created in 2009, the COVID-19
9	pandemic and its impact on state funding has demonstrated that more must be
10	done to reduce the operational costs of state entities.
11	§102. Definitions
12	As used in this Part, the following terms shall have the following meanings,
13	unless the context requires otherwise:
14	(1) "Activity" means a distinct subset of functions or services within a
15	program.
16	(2) "Agency" means and includes any office, department, board, commission,
17	institution, division, office, instrumentality, or functional group, heretofore existing
18	or hereafter created, that is authorized to exercise, or that does exercise, any
19	functions in the executive branch of state government. "Agency" shall not mean any
20	public institution of postsecondary education, any postsecondary education
21	governing or management board, or any entity under the control of a public
22	institution of postsecondary education or postsecondary education governing or
23	management board.
24	(3) "Commission" means the Commission on Streamlining Government
25	Commission.
26	(4) "Functions" means duties, jurisdiction, powers, rights, and obligations,
27	conferred or imposed upon, or vested in, any agency by law, or exercised, performed,
28	or discharged by any agency without contravention of any provision of law.
29	(5) "Objective" is a specific and measurable target for achievement which
30	describes the exact results sought, which is expressed in an outcome-oriented

1	statement that may reflect effectiveness, efficiency, or quality of work, and which
2	may be either numeric or non-numeric.
3	(6) "Performance indicator" means a statement identifying an activity, input,
4	output, outcome, achievement, ratio, efficiency, or quality to be measured relative
5	to a particular goal or objective in order to assess an agency's performance.
6	Performance indicator shall also mean measurement of any other aspect of
7	performance as determined by rule issued by the commissioner of administration
8	under the provisions of the Administrative Procedure Act.
9	(7) "Performance standard" means the expected level of performance
10	associated with a particular performance indicator for a particular period.
11	(8) "Program" means a grouping of activities directed toward the
12	accomplishment of a clearly defined objective or set of objectives.
13	(9) "Quality" means degree or grade of excellence.
14	§103. Commission on Streamlining Government Commission; established
15	A. There is established the Commission on Streamlining Government
16	Commission to examine each agency's constitutional and statutory activities,
17	functions, programs, services, powers, duties, and responsibilities to determine which
18	of these activities, functions, programs, services, powers, duties, and responsibilities
19	can be $(1)$ eliminated, $(2)$ streamlined, $(3)$ consolidated, $(4)$ privatized, or $(5)$
20	outsourced in an effort to reduce the size of state government.
21	
	B. The commission shall target agencies whose activities, functions,

22	(12) One individual, appointed by the president of the Senate, selected
23	from a list of three individuals nominated by the Louisiana AFL-CIO, which
	individual shall be subject to Senate confirmation.
24	E. The commission may hold public hearings as part of its evaluation process,
24 25	and may appoint advisory groups to conduct studies, research, or analyses, and make
	reports and recommendations with respect to a matter within the jurisdiction of the

8	§104. Procedure
9	A. Reports submitted by the Commission on Streamlining Government
10	Commission pursuant to this Section may include any of or any combination of the
11	following:
12	(1) Recommendations to eliminate, streamline, consolidate, privatize, or
13	outsource constitutional and statutory agency activities, functions, programs,
14	services, powers, duties, and responsibilities to provide the same or greater type and
15	quality of activity, function, program, or service that will result in cost reduction or
16	greater efficiency or effectiveness.
17	(2) Recommendations to ensure that agency activities, functions, programs,
18	and services are not duplicative and are necessary, meeting or exceeding
19	performance standards, and meeting the needs of Louisiana citizens.
20	(3) Recommendations for the elimination, consolidation, privatization, or
21	outsourcing of an agency to provide a more cost efficient or more effective manner
22	of providing an activity, function, program, or service.
23	(4) Recommendations providing for the use of alternative resources to <u>for</u> the
24	operation of agencies, activities, functions, programs, and services to provide them
25	$\underline{in}$ a more cost-effective manner without impacting the quality or availability of
26	needed services.
27	(5) Recommendations for standards, processes, and guidelines for agencies
28	to use in order to review and evaluate government activities, functions, programs,
29	and services to eliminate, streamline, consolidate, privatize, or outsource.
30	B.(1) The commission shall submit an initial report of its recommendations,

1	including recommendations requiring legislation or administrative action, to the
2	governor, the president of the Senate, the speaker of the House of Representatives,
3	the Senate and Governmental Affairs Committee, the House and Governmental
4	Affairs Committee, and the commissioner of administration no later than December
5	15, <del>2009</del> <u><b>2020</b></u> .
6	(2) The commission shall prepare the recommendations in the report as a
7	reorganization plan and submit the plan to the Senate and Governmental Affairs
8	Committee and the House and Governmental Affairs Committee for consideration
9	by January 4, $\frac{2010}{2021}$ , and the committees, meeting as a joint committee, shall
10	review the plan by February 1, <del>2010</del> <b><u>2021</u></b> .
11	(3) Executive and legislative action as may be necessary to implement the
12	reorganization plan as approved or modified by the two committees meeting jointly
13	shall be taken as soon as possible.
14	C. The commission shall submit a report annually before January first
15	consisting of the status and implementation of the reorganization plan approved by
16	the Senate and Governmental Affairs Committee and the House and Governmental
17	Affairs Committee to the governor, the president of the Senate, the speaker of the
18	House of Representatives, the Senate and Governmental Affairs Committee, the
19	House and Governmental Affairs Committee, and the commissioner of
20	administration.
21	§105. Staff support
22	The staffs of the Senate, House of Representatives, Legislative Fiscal Office,
23	legislative fiscal office, legislative auditor, office of the governor, and division of
24	administration may shall, upon request, provide staff support and otherwise assist
25	the commission as requested by the commission. The commission may submit a
26	written request to the president of the Senate, the speaker of the House of
27	Representatives, the legislative fiscal officer, the legislative auditor, or the
28	commissioner of administration, for specific support and assistance to be provided
29	by the staffs of their respective agencies.
30	§106. Agency cooperation and assistance

1	A. Each agency and political subdivision shall furnish aid, services, and
2	assistance as may be requested by the commission.
3	B. To the extent permitted by and in accordance with R.S. 44:1 et seq., each
4	officer, agency, and political subdivision shall make available all facts, records,
5	information, and data requested by the commission and in all ways cooperate with
6	the commission in carrying out the functions and duties imposed by this Part.
7	§107. Finances
8	A. The commission may apply for, contract for, receive, and expend for
9	purposes of this Part any appropriation or grant from the state, its political
10	subdivisions, the federal government, or any other public or private source.
11	B. The books and records of the commission shall be subject to audit by the
12	legislative auditor pursuant to R.S. 24:513.
13	§108. Effect on other law
14	This Part shall not be deemed to supercede or limit the provisions of Part XII
15	of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
16	§109. Termination of Part
17	This Part shall become null and of no effect on January 12, $\frac{2012}{2023}$ .
18	Section 2. This Act shall become effective upon signature by the governor or, if not
19	signed by the governor, upon expiration of the time for bills to become law without signature
20	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
21	vetoed by the governor and subsequently approved by the legislature, this Act shall become
22	effective on the day following such approval.
