2	To appropriate funds from certain sources in specific amounts for the making of		
3	supplemental appropriations to the capital outlay budget for Fiscal Year 2020-2021;		
4	to provide for an effective date; and to provide for related matters.		
5	Be it enacted by the Legislature of Louisiana:		
6	Section 1. The following revisions are hereby made to Act 2 of the 2020 First		
7	Extraordinary Session of the Legislature for the purpose of making supplemental capital		
8	outlay appropriations for Fiscal Year 2020-2021:		
9	A. Notwithstanding any provision of law to the contrary, including the		
10	provisions of the Capital Outlay Act, the appropriation to 01/109 COASTAL		
11	PROTECTION AND RESTORATION AUTHORITY for the Coastal Protection		
12	Projects, Planning and Construction (Statewide) project is hereby amended and		
13	reenacted to include an appropriation made out of State General Fund (Direct) Non-		
14	Recurring Revenues:		
15	On page 8, delete line 36 in its entirety and insert the following:		
16 17 18	"Payable from State General Fund (Direct)Non-Recurring RevenuesTotal\$ 3,000,000\$ 1,078,416,654		

Provided, however, that \$3,000,000 of the State General Fund (Direct) Non-Recurring
Revenues shall be used to fund levee improvements in the North Lafourche Conservation
Levee and Drainage District."

B. On page 76, delete lines 21 through 28 in their entirety.

- 1 Section 2. This Act shall become effective upon signature by the governor or, if not
- 2 signed by the governor, upon expiration of the time for bills to become law without signature
- 3 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 4 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 5 effective on the day following such approval.
