**1** AMENDMENT NO. 1**2** On page 1, at the end of line 16, delete "pursuant to" and at the beginning of line 17, delete  
**3** "the procedure provided by in" and insert "in accordance with"**4** AMENDMENT NO. 2**5** On page 1, delete lines 18 through 20 and on page 2, delete lines 1 through 11 and insert the  
**6** following:**7** "~~B.(1) The legislature, in consultation with the public health authority, by a petition signed~~  
**8** ~~by a majority of the surviving members of either house, may terminate a state of public~~  
**9** ~~health emergency at any time. This petition terminating the public health emergency may~~  
**10** ~~establish a period during which no other declaration of public health emergency may be~~  
**11** ~~issued. Thereupon, the governor shall issue an executive order or proclamation ending the~~  
**12** ~~state of public health or emergency. The House of Representatives or the Senate may~~  
**13** ~~terminate a state of public health emergency at any time by a petition signed by the majority~~  
**14** ~~of its surviving members. The petition may establish and confine the applicability of a~~  
**15** ~~period during which no other declaration of a public health emergency may be issued and~~  
**16** ~~shall include a date and time on which the state of public health emergency terminates. The~~  
**17** ~~petition shall be submitted to the clerical officer of the respective house. Upon receipt of a~~  
**18** ~~valid petition, the clerical officer shall transmit copies of the signed petition to the other~~  
**19** ~~house, the governor, and the secretary of state. The clerical officer shall give notice to the~~  
**20** ~~public of the termination of the state of public health emergency by publishing the petition~~  
**21** ~~on the joint legislative website and in the official journal of the state. No additional action~~
