15 to exceed forty hours and not including hours of overtime work.**16** (8) "Work-sharing benefits" means unemployment benefits payable to employees in
17 an affected unit under an approved work-sharing plan, as distinguished from the
18 unemployment benefits otherwise payable under the unemployment insurance provisions of
19 this state.**20** (9) "Work-sharing plan" means a plan submitted by an employer, for approval by the
21 administrator, under which the employer requests the payment of work-sharing benefits to
