HOUSE CONCURRENT RESOLUTION NO. 38

BY REPRESENTATIVE COUSSAN AND SENATOR HENSGENS

ENERGY PRODUCTION: Memorializes Congress and the Louisiana Delegation to defeat the "Oceans-Based Climate Solutions Act of 2020"

A CONCURRENT RESOLUTION

2	To memorialize the Louisiana Congressional Delegation and the United States Congress to
3	take such actions as are necessary to defeat passage of the "Oceans-Based Climate
4	Solutions Act of 2020" and to protect future opportunities for oil and gas exploration
5	on the Outer Continental Shelf.
6	WHEREAS, Raúl M. Grijalva (D-Ariz.), Chairman of the United States House
7	Committee on Natural Resources has unveiled legislation entitled the "Oceans-Based
8	Climate Solutions Act of 2020" with the intent to include ocean impacts of climate change
9	in the discussions of methods to address climate change mitigation; and
10	WHEREAS, in an effort to restore coastal ecosystems, strengthen marine mammal
11	conservation, reduce carbon emissions from shipping vessels, improve international ocean
12	governance, and pursue other oceans-related solutions to the climate change crisis, the
13	legislation seeks to end the federal offshore oil-leasing program; and
14	WHEREAS, although these pursuits sound laudable, it is important to remember that
15	the Louisiana oil and gas industry supports nearly two hundred and fifty thousand jobs inside
16	the state of Louisiana and more in adjoining states, it accounts for fourteen percent of the
17	state's tax revenue, and supplies \$73 billion of the state's gross domestic product; and
18	WHEREAS, an analysis has found that such a proposal, if enacted, would cause the
19	loss of nearly one million jobs nationwide in the first twelve to twenty-four months, forty-
20	eight thousand of which are located here in Louisiana; and

1	WHEREAS, this proposal would significantly reduce our domestic energy
2	production, making our nation more dependent on less reliable, less safe foreign sources for
3	energy produced under weaker environmental standards and a higher carbon footprint; and
4	WHEREAS, with energy demand expected to continue to rise until at least 2040,
5	Louisiana currently produces nearly twenty percent of our nation's energy, refines
6	approximately forty-five percent of the total United States petroleum, and processes fifty-
7	one percent of the nation's natural gas; and
8	WHEREAS, while meeting this demand year after year, Louisiana energy producers
9	are at the forefront of carbon emissions reduction technology development like carbon
10	capture and storage that can capture ninety percent of carbon emissions from fossil fuels; and
11	WHEREAS, in addition, the offshore oil and gas industry in the United States
12	operates under some of the most stringent environmental rules in the world and its
13	infrastructure also supports some of the most abundant fish habitat providing fishing
14	opportunities that have made Louisiana the "Sportsman's Paradise"; and
15	WHEREAS, protecting leasing and production in the Outer Continental Shelf will
16	help combat climate change by helping our state combat coastal land loss and sustain oil and
17	gas operations in the Gulf of Mexico critical to energy innovations needed to reduce carbon
18	emissions; and
19	WHEREAS, Louisiana and its local economies, especially communities reliant on
20	energy development and production, have felt an outsized impact from the COVID-19
21	pandemic and are expected to face a slower recovery than many other states because of our
22	large service sector employment; and
23	WHEREAS, Louisiana already faces major budget shortfalls that will impact schools,
24	emergency services, and other essential services; and
25	WHEREAS, under the provisions of the Gulf of Mexico Security Act, in 2019 alone
26	energy production on the Outer Continental Shelf generated over \$155 million to the state
27	of Louisiana used for coastal restoration and hurricane preparedness; and
28	WHEREAS, ensuring access to available leasing acreage on the Outer Continental
29	Shelf will protect offshore energy production as an essential part of our state's budget when
30	our state and local governments need it the most.

THEREFORE BE IT RESOLVED, that the Legislature of Louisiana does hereby
memorialize the Louisiana Congressional Delegation and the United States Congress to take
such actions as are necessary to defeat passage of the "Oceans-Based Climate Solutions Act
of 2020" and to protect future opportunities for oil and gas exploration on the Outer
Continental Shelf.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
presiding officers of the Senate and the House of Representatives of the Congress of the
