PORTS/HARBORS/TERMINALS. Provides relative to the Louisiana International Deep Water Gulf Transfer Terminal Authority. (gov sig) (Item #50)

SUMMARY OF HOUSE AMENDMENTS TO THE SENATE BILL

- 1. Reduces <u>from 11 to 5</u> the number of commissioners appointed by the governor.
- 2. Provides for one member selected from a list of two nominees one nominee submitted by the La. River Pilots' Association and one nominee submitted by the La. Maritime Association.
- 3. Removes requirement that members selected by the legislative presiding officers be from the St. Bernard or Plaquemines delegation and provides that the project is located.
- 4. Adds provision that the six year term for commissioner not apply to members appointed by the legislative presiding officers.

DIGEST OF THE SENATE BILL AS RETURNED TO THE SENATE

SB 7 Reengrossed 2020 Second Extraordinary Session Hewitt

<u>Present law</u> established a 15-member board of commissioners for the La. International Deep Water Gulf Transfer Terminal Authority, consisting of the secretary of the Dept. of Economic Development and the secretary of the Dept. of Transportation and Development, the chairman of the House and Senate committees on transportation, highways, and public works or their designees and 11 commissioners to be appointed by the governor.

<u>Proposed law</u> reduces the membership of the board <u>from</u> 15 to 9 and removes the chairmen of the House and Senate committees on transportation, highways, and public works and reduces the number of members appointed by the governor to five.

Present law requires that commissioners be chosen as follows:

(1) One member selected from a list of three nominees submitted by the Ports Association of La.

(2) One member selected from a list of three nominees submitted by the La. Association of Business and Industry.

(3) One member selected from a list of three nominees submitted by the La. Maritime Association.

(4) One member selected from a list of three nominees submitted by the La. River Pilots' Association.

(5) Two members at-large; one member appointed by the American Federation of Labor-Congress of Industrial Organizations.

(6) One member selected from a list of three nominees submitted by the president of the Senate/

(7) One member selected from a list of three nominees submitted by the speaker of the House of Representatives.

(8) One member selected from a list of three nominees who are residents of Plaquemines Parish, submitted jointly by the chief executive officer and the governing authority of Plaquemines Parish.

(9) One member selected by the N.O. Public Belt Railway and appointed by the governor, who must be a nonvoting member.

<u>Proposed law</u> reduces the member at-large appointments <u>from</u> two to one; provides that two members be selected by the legislative presiding officers from the legislature who represents the legislative district in which the project is located or their designees and that they service a term concurrent with the respective legislative presiding officer.

<u>Proposed law</u> removes one member each selected by the La. River Pilots' Association and the La. Maritime Association and provides that one member be selected from a list of two nominees with the La. River Pilots' Association and the La. Maritime Association each submitting one nominee.

<u>Proposed law</u> removes the member from the House that is selected from a list of three names submitted by the speaker of the House of Representatives and removes the member from the Senate that is selected from a list of three nominees submitted by the president of the Senate.

<u>Proposed law</u> removes the member selected from a list of three names submitted jointly by the chief executive officer and the governing authority of Plaquemines Parish.

<u>Proposed law</u> removes the member selected by the N.O. Public Belt Railway who is appointed by the governor.

<u>Proposed law</u> removes the member that is selected from a list of three names submitted by the La. Maritime Association and the member that is selected from a list of three names submitted by the La. River Pilots Association, and adds that one member shall be selected from a list of two nominees, with one nominee being submitted by both the La. River Pilots' Association and the La. Maritime Association.

<u>Present law</u> specifies that the commissioners appointed are appointed for terms of six years and that no commissioner can serve more than two consecutive terms.

<u>Present law</u> requires the board of commissioners to seek the approval of the House and Senate committees on transportation, highways, and public works and the Joint Legislative Committee on the Budget prior to the adoption of any rule or regulation for the maintenance and operation of the authority.

Proposed law removes present law.

<u>Present law</u> requires the board of commissioners to elect a president, two vice-presidents, a secretary, and a treasurer from among the members of the board.

<u>Proposed law</u> reduces the number of vice-presidents to be elected <u>from</u> two to one.

<u>Present law</u> specifies that all matters to be acted upon by the board of commissioners or the executive board require the affirmative vote of a majority of the board, with the exception that the affirmative vote of not less than ten commissioners is required to select the executive director.

<u>Proposed law</u> changes <u>present law</u> by requiring the affirmative vote of a majority of the board and reduces the number of affirmative votes of commissioners to select the executive director from 10 to 6.

<u>Present law</u> requires the board to make an annual report to the governor, the House and Senate committees on transportation, highways, and public works, and the Joint Legislative Committee on the Budget.

<u>Proposed law</u> removes the Joint Legislative Committee on the Budget from the entities to which the board must make an annual report. <u>Proposed law</u> further provides that the annual report shall be submitted not later than February 1st of each year and that the report shall

include a summary of the authority's progress, future plans for the authority's development program and financial report.

Provides that terms of the current members of the board shall not be altered by proposed law.

Effective upon signature of the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor.
