TAX/INCOME TAX: Creates an individual income tax checkoff for the Sexual Trauma Awareness and Response (STAR) organization

AN ACT

2	To enact Subpart BBB of Part I of Chapter 1 of Subtitle II of Title 47 of the Louisiana
3	Revised Statutes of 1950, to be comprised of R.S. 47:120.351, relative to state
4	individual income tax return checkoffs for certain donations; to provide for a method
5	for individuals to donate all or a portion of any refund due to them to the Sexual
6	Trauma Awareness and Response organization; to provide for the administration and
7	disbursement of donated monies; to provide for reporting; to provide for an effective
8	date; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
0	Section 1. Subpart BBB of Part I of Chapter 1 of Subtitle II of Title 47 of the
1	Louisiana Revised Statutes of 1950, comprised of R.S. 47:120.351, is hereby enacted to read

17	A. Every individual who files an individual income tax return for the current
18	tax year and who is entitled to a refund may designate on his current year return that

20	donated to the Sexual Trauma Awareness and Response (STAR) organization in lieu

of that amount being paid to him as a refund. In this case, the refund shall be reduced by the amount so designated. The designation shall be made at the time of filing the current year tax return and shall be made upon the income tax return form 4 as prescribed by the secretary of the Department of Revenue. Donated monies shall be administered by the secretary and distributed to the Sexual Trauma Awareness and Response (STAR) organization in accordance with the provisions of R.S. 7 47:120.37. No donation made pursuant to the provisions of this Subpart shall be 8 invalid for want of an authentic act. B. The House Committee on Ways and Means may, at its discretion, request 10 a report from the Sexual Trauma Awareness and Response (STAR) organization relative to its operations. The form and content of the report shall be prescribed by 12 the chairman of the committee but shall at a minimum contain a detailed explanation of revenues and expenditures, as well as a description of the organization's activities. The committee may summon any person employed by or associated with the Sexual Trauma Awareness and Response (STAR) organization to provide testimony with respect to the report. 17 Section 2. The provisions of this Act shall be applicable to taxable years beginning 18 on or after January 1, 2022.

Abstract: Provides for an individual income tax checkoff for donations to the Sexual Trauma Awareness and Response (STAR) organization.

Proposed law provides for an income tax checkoff pursuant to which an individual can donate all or a portion of his state income tax refund to the Sexual Trauma Awareness and Response (STAR) organization in lieu of that amount being paid as a refund.

Proposed law requires donated monies to be administered by the secretary of the Dept. of Revenue and to be quarterly disbursed to STAR.

Proposed law authorizes the House Committee on Ways and Means, at its discretion, to request reports from STAR relative to its operations. The form and content of the report shall be prescribed by the chairman of the committee but shall at a minimum contain a

detailed explanation of revenues and expenditures, as well as a description of the organization's activities.
