WEIGHTS/MEASURES: Increases certain weights and measures registration and license fees under the jurisdiction of the Department of Agriculture and Forestry

2	To amend and reenact R.S. 3:4622(B)(1) through (3), (C), and (E), relative to fee increases;
3	to provide for commercial weighing and measuring device registration fees; to
4	provide for the weighmaster license fee; to provide for service person registration
5	fee; to provide for an effective date; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 3:4622(B)(1) through (3), (C), and (E) are hereby amended and

Abstract: Increases the registration fees for commercial weighing and measuring devices, the license fee for weighmasters, and the registration fee of each service person under the jurisdiction of the Dept. of Agriculture and Forestry, effective July 1, 2021.

<u>Present law</u> specifies that the registration fee for each commercial weighing and measuring device shall be as follows:

(1)	Category 1zero to 1,000 pounds weight	\$35
(2)	Category 2over 1,000 to 10,000 pounds weight	\$80

(3) Category 3--over 10,000 pounds weight \$185

<u>Proposed law</u> increases the fees in <u>present law</u> as follows: "Category 1" <u>from</u> \$35 to a range of up to \$50; "Category 2" <u>from</u> \$80 to a range of up to \$135; and "Category 3" <u>from</u> \$185 to a range of up to \$250.

<u>Present law</u> requires each weighmaster licensed by the Commission of Weights and Measures to pay an annual license fee of \$75.

Proposed law increases the weighmaster license fee from \$75 to \$100.

<u>Present law</u> requires the registration fee for each service agency to be \$100 and each service person to be \$50.

Proposed law increases the registration fee for each service person from \$50 to \$65.

Effective July 1, 2021.
