TAX/LOCAL. Exempts certain infused prescription drugs from local sales tax. (7/1/21)

AN ACT

2	To enact R.S. 47:305.75 and 337.9(C)(27), relative to local sales and use tax; to provide an
3	exemption from local sales and use tax for the purchase of certain infused
4	prescription drugs; to provide for the applicable diseases and conditions; to provide
5	for limitations; to provide for effectiveness; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 47:305.75 and 337.9(C)(27) are hereby enacted to read as follows:
8	§305.75. Exemption; infused prescription drugs for treating certain diseases
9	and conditions
10	A. The tax imposed by the political subdivisions of the state shall not
11	apply to the procurement and administration of prescription drugs used
12	exclusively by the patient in his medical treatment when administered
13	exclusively to the patient by a physician, nurse, or other health care professional
14	by infusion in a physician's office where patients are not regularly kept as bed
15	patients for twenty-four hours or more.

27	Section 2. This Act shall become effective on July 1, 2021; if vetoed by the governor
28	and subsequently approved by the legislature, this Act shall become effective on July 1,
29	2021, or on the day following such approval by the legislature, whichever is later.

<u>Present law</u> provides for a mandatory exemption for prescription drugs from state sales and use tax, a mandatory exemption from state and local sales and use tax for certain chemotherapy prescription drugs, and authorizes an optional exemption for other prescription drugs from local sales and use tax if a local taxing authority adopts the exemption by ordinance or resolution.

<u>Proposed law</u> creates a mandatory local sales and use tax exemption for infused prescription drugs that are administered by a medical professional in a physician's office where patients are not regularly kept as bed patients for 24 hours or more.

<u>Proposed law</u> provides that the exemption applies only to drugs prescribed for the diseases and conditions listed.

Effective July 1, 2021.
