1 AN ACT 2 To enact Chapter 12-A of Title 51 of the Louisiana Revised Statutes of 1950, to be 3 composed of R.S. 51:1371, relative to broadband development; to provide legislative 4 intent; to encourage parishes and municipalities to utilize public-private partnership 5 projects; to authorize parishes and municipalities to create data authorities; to 6 authorize the use of funds; to prohibit a partnership from also being a service 7 provider; and to provide for related matters. 8 Be it enacted by the Legislature of Louisiana: 9 Section 1. Chapter 12-A of Title 51 of the Louisiana Revised Statutes of 1950, 10 composed of R.S. 51:1371, is hereby amended and reenacted to read as follows: 11 CHAPTER 12-A. PUBLIC-PRIVATE PARTNERSHIP AGREEMENTS 12 §1371. Legislative findings; authorization 13 A. The legislature finds that the expansion of broadband in the state is a 14 necessary and vital component in the ongoing efforts to strengthen the economy, 15 provide quality education, encourage innovation and entrepreneurship, compete on 16 a national and global scale, expand quality healthcare to all communities, and 17 improve the quality of life for all citizens of this state. 1 participate in the pursuit of statewide connectivity by utilizing public-private 2 partnership projects when in the best interest of the taxpayer, to help the state finance 3 development and improvement of broadband and high-speed data infrastructure and 4 meet local broadband and high-speed data infrastructure needs. B. Parishes and municipalities may create broadband or high-speed data 5 6 transmission authorities, which may enter into agreements with public or private 7 entities to construct, maintain, repair, or operate broadband or high-speed data 8 infrastructure projects. 9 C. Broadband or high-speed data transmission authorities may invest public 10 and private money to finance public-private partnership projects initiated pursuant 11 to this Chapter, subject to compliance with all applicable state law relative to the use 12 of public funds. 13 D. Any public-private partnership project formed under the transmission 14 authority, as provided for in Subsection B of this Section, shall be prohibited from 15 serving as the internet service provider.

Abstract: Allows parishes and municipalities to utilize public-private partnership projects for purposes of broadband and high-speed data infrastructure expansion.

<u>Proposed law</u> provides legislative findings.

<u>Proposed law</u> encourages municipalities and parishes to utilize public-private partnership projects (PPPs).

<u>Proposed law</u> allows municipalities and parishes to create data transmission authorities which can enter into agreements with public or private industries in order to create and maintain broadband and high-speed data infrastructure.

<u>Proposed law</u> allows the data transmission authorities to invest public and private funds to finance PPPs, subject to compliance with present law.

<u>Proposed law</u> prohibits a partnership created under <u>proposed law</u> from being the internet service provider.
