PUBLIC LANDS/SCHOOLS: Authorizes the transfer of certain state property in East Baton Rouge Parish

AN ACT

To authorize and provide for the transfer of certain state property; to authorize the transfer
of certain state property in East Baton Rouge Parish; to provide for property
descriptions; to provide for the reservation of mineral rights; to provide for the
proceeds; to provide relative to terms and conditions; to provide an effective date;
and to provide for related matters.
Be it enacted by the Legislature of Louisiana:
Section 1. The Board of Supervisors of Southern University and Agricultural and
Mechanical College and the commissioner of administration, notwithstanding any other
provision of law to the contrary, are hereby authorized and empowered to convey, transfer,
assign, lease, or deliver any interest, excluding mineral rights, the state may have in all or
any portion of the following described parcels of property to Isaiah Pullet:
PARCEL #2384418
NORTH 40 FT. OF LOT 10 SQ. 224 OR 20 F & L T, MEASURING 30 FT. FRONT ON EAST SIDE OF 21ST. ST. (SHOULD INCLUDE A PART OF LOT 11) 1974. (P-24971)
PARCEL #2391880
NORTH 40 FEET OF LOT 10 SQ. 224 OR 20, MEAS. 30 FEET FRONT ON THE EAST SIDE OF 21ST ST. (SHOULD INCLUDE A PART OF LOT 11) 1974 (P-24,971)
Section 2. The Board of Supervisors of Southern University and Agricultural and
Mechanical College and the commissioner of administration are hereby authorized to enter
into such agreements, covenants, conditions, and stipulations and to execute such documents

- 1 as necessary to properly effectuate any conveyance, transfer, assignment, lease, or delivery
- 2 of title, excluding mineral rights, to the properties described in Section 1 of this Act, and as
- 3 more specifically described in any such agreements entered into and documents executed
- 4 by and between the Board of Supervisors of Southern University and Agricultural and
- 5 Mechanical College, the commissioner of administration, and Isaiah Pullet, in exchange for
- 6 consideration proportionate to the appraised value of the properties.
- 7 Section 3. The proceeds of any sale or transfer of property as authorized by this Act
- 8 shall be retained by the Southern University System.
- 9 Section 4. This Act shall become effective upon signature by the governor or, if not
- signed by the governor, upon expiration of the time for bills to become law without signature
- by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 13 effective on the day following such approval.
