MTR VEHICLE/LICEN PLATES: Creates the "West Feliciana Parish Schools" and the "En français S.V.P" specialty license plate

AN ACT

2	To enact R.S. 47:463.210 and 463.211, relative to motor vehicle special prestige license
3	plates; to provide for the "West Feliciana Parish Schools" special prestige license
4	plate; to establish the "En français S.V.P" specialty license plate; to provide for the
5	creation, issuance, design, implementation, fees, distribution, and rule promulgation
6	applicable to such license plates; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 47:463.210 and 463.211 are hereby enacted to read as follows:
9	§463.210. Special prestige license plate; "West Feliciana Parish Schools"
10	A. The secretary of the Department of Public Safety and Corrections shall
11	establish a special prestige motor vehicle license plate to be known as the "West
12	Feliciana Parish Schools" plate, provided there is a minimum of one thousand
13	applicants for such plate. The plate shall be restricted to use on passenger cars,
14	pickup trucks, motorcycles, recreational vehicles, and vans.
15	B. The secretary shall work in conjunction with the superintendent of West
16	Feliciana Parish Schools, or his designee, to select the color and design of the plate,
17	provided it is in compliance with R.S. 47:463(A)(3). The design shall include the
18	words "West Feliciana Parish Schools".
19	C. The special prestige license plate shall be issued, upon application, to any
20	citizen of Louisiana in the same manner as any other motor vehicle license plate.

12	A. The secretary of the Department of Public Safety and Corrections shall
13	establish a special prestige motor vehicle license plate to be known as the "En
14	français S.V.P" plate, provided there are a minimum of one thousand applicants for
15	such plate. The plate shall be restricted to use on passenger cars, pickup trucks,
16	recreational vehicles, motorcycles, and vans.
17	B. The secretary shall work in conjunction with the Saint LUC French
18	Immersion and Cultural Campus Board of Directors to select the color and design
19	of the plate, provided the design is in compliance with R.S. 46:463(A)(3). The
20	design shall include the phrase "Saint LUC. En français SVP " and shall also include
21	a prominent logo.
22	C. The special prestige license plate shall be issued, upon application, to any
23	citizen of Louisiana in the same manner as any other motor vehicle license plate.
24	D. The department shall collect an annual royalty fee of twenty-five dollars
25	that shall be disbursed in accordance with Subsection E of this Section. This royalty
26	fee shall be in addition to the standard motor vehicle license tax imposed by Article
27	VII, Section 5 of the Constitution of Louisiana, and a handling fee of three dollars
28	and fifty cents for each plate to be retained by the department to offset a portion of
29	administrative costs.

1 E. The annual royalty fee shall be collected by the department and disbursed 2 solely to fund programming at the Saint LUC French Immersion and Cultural 3 Campus. F. The secretary shall promulgate and adopt rules and regulations as are 4 5 necessary to implement the provisions of this Section. 6 Section 2. The Department of Public Safety and Corrections, office of motor 7 vehicles, is hereby directed to create these special prestige license plates when the applicable 8 statutory provisions are met and its system is updated to accommodate the creation of new 9 plates.

Abstract: Creates the "West Feliciana Parish Schools" and "En français S.V.P" special prestige license plates. Provides for the creation, issuance, design, implementation, fees, distribution, and promulgation of rules applicable to these license plates.

<u>Proposed law</u> requires the Dept. of Public Safety and Corrections issue special prestige license plates to be known as the "West Feliciana Parish Schools" and the "En français S.V.P" license plates, provided there are a minimum of 1,000 applicants for such plates.

<u>Proposed law</u> requires the secretary work in conjunction with the superintendent of West Feliciana Parish Schools, or his designee, for the color and design of the "West Feliciana Parish Schools" plate.

<u>Proposed law</u> requires the secretary work in conjunction with the Saint LUC French Immersion and Cultural Campus Board of Directors to select the color and design of the "En français S.V.P" license plate, provided the design is in compliance with R.S. 47:463(A)(3). Requires the design include the phrase "Saint LUC. En français SVP" and a prominent logo.

<u>Proposed law</u> specifies the license plates will be issued to any citizen of La. in the same manner as any other motor vehicle license plate.

<u>Proposed law</u> requires the department to collect an annual royalty fee of \$25 in addition to the standard motor vehicle license tax and a \$3.50 handling fee for each plate to be retained by the department to offset a portion of administrative costs.

<u>Proposed law</u> requires monies received from the royalty fees for the "West Feliciana Parish Schools" be forwarded to the West Feliciana Parish Public School System.

<u>Proposed law</u> requires monies received from the royalty fees for the "En français S.V.P" be disbursed solely to fund programming at the Saint LUC French Immersion and Cultural Campus.

<u>Proposed law</u> requires the secretary to adopt rules and regulations to implement the provisions provided for in proposed law.

Directs the office of motor vehicles to create the "West Feliciana Parish Schools" and "En français S.V.P" specialty license plates when the applicable statutory provisions are met and its system is updated to accommodate the creation of new plates.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Transportation</u>, Highways and Public Works to the original bill:

- 1. Require the Department of Public Safety and Corrections issue a special prestige license plate to be known as the "En français S.V.P" license plate, provided there is a minimum of 1,000 applicants for such plate.
- 2. Require the secretary work in conjunction with the Saint LUC French Immersion and Cultural Campus Board of Directors to select the color and design of the plate, provided the design is in compliance with R.S. 47:463(A)(3). Require the design include the phrase "Saint LUC. En français SVP" and a prominent logo.
- 3. Add a provision to specify the license plate be issued, upon application, to any citizen of Louisiana in the same manner as any other motor vehicle license plate.
- 4. Require the department collect an annual royalty fee of \$25 in addition to the standard motor vehicle license tax and a \$3.50 handling fee for each plate to be retained by the department to offset a portion of administrative costs.
- 5. Require monies received from the royalty fees be disbursed solely to fund programming at the Saint LUC French Immersion and Cultural Campus.
- 6. Require the secretary to promulgate and adopt rules and regulations to implement the provisions of proposed law.
- 7. Direct the office of motor vehicles to create the "En français S.V.P" specialty license plate when the applicable statutory provisions are met and its system is updated to accommodate the creation of new plates.
- 8. Make technical changes.
