Establishes and provides for the Power-Based Violence Review. (8/1/21)

Proposed law creates the LA Power-Based Violence Review Panel and requires it to meet at least four times per year. Requires panel to (1) evaluate policies and practices of institutions of postsecondary education, their systems, and the Board of Regents (BOR) regarding reporting, investigating, and adjudicating power-based violence; (2) advise and assist institutions and BOR in coordinating procedures to provide power-based violence prevention programs; (3) serve as an advisory agency to the legislature, the governor, the BOR, and the board of supervisors of each postsecondary education system. Provides for cooperation of BOR, each postsecondary education system and institution, and each law enforcement agency to make available all facts, records, information, and data required by the panel in carrying out its functions.

Effective August 1, 2021.

**EXPENDITURE EXPLANATION**

Proposed law may create a nominal SGF expenditure for an unspecified state entity associated with the administrative costs of the newly created LA Power-Based Violence Review Panel. The bill in its current posture does not provide for the membership of the LA Power-Based Violence Review Panel, placement of the review panel under the control or organizational structure of any executive or legislative agency, and does not specify whether the panel shall serve with or without compensation. The LFO assumes members will serve without pay but will be eligible for reimbursement of travel costs in accordance with state travel regulations. It is unclear which entity will be responsible for such reimbursements and to provide for general administrative expenses associated with hosting meetings, providing advisory functions for state entities, collecting and processing data, and the cost of distributing any reports or findings.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
