2	To commend the Louisiana State Employees' Retirement System (LASERS) on the occasion			
3	of its seventy-fifth anniversary.			
4	WHEREAS, LASERS was established by Act No. 126 of 1946 Regular Session of			
5	the Legislature to provide retirement allowances and other benefits for state officers and			
6	employees and their beneficiaries; and now, seventy-five years later, LASERS celebrates its			
7	monumental anniversary in 2021; and			
8	WHEREAS, LASERS provides a sound retirement plan for state employees through			
9	prudent management and exceptional service and by utilizing the highest ethical standards			
10	and integrity; LASERS remains a strong, reliable presence in the lives of its members; and			
11	WHEREAS, LASERS, with an overall annual retirement benefit payment of one			
12	billion three hundred million dollars, constitutes a strong and positive impact throughout			
13	Louisiana, fueling economic activity in every parish; and			
14	WHEREAS, the nearly one hundred thousand members of LASERS include public			
15	employees from across Louisiana, such as corrections officers, nurses, agricultural			
16	inspectors, social workers, and enforcement agents, and their beneficiaries; and			

1	WHEREAS, LASERS has represented the state of Louisiana positively: it has		
2	worked with the legislature to implement reforms expected to result in a three billion dollar		
3	cost savings to the retirement system; it has saved over ten million dollars annually through		
4	internal portfolio management, enough to fund the salaries of all LASERS employees; it has		
5	invested in Louisiana companies; it has implemented changes to decrease the employe		
6	percentage of payroll or cost of benefit earned; and it has decreased the unfunded accrued		
7	liability; and		
8	WHEREAS, the LASERS board of trustees has adopted strong measures to		
9	strengthen the long-term future of the fund to ensure members receive benefits they have		
10	earned after dedicating a career to public service; and		
11	WHEREAS, LASERS merits the highest commendation and sincere congratulations		
12	for its seventy-five years of service to the state of Louisiana and dedication to its citizens.		
13	THEREFORE, BE IT RESOLVED that the House of Representatives of the		
14	Legislature of Louisiana does hereby commend and congratulate the Louisiana State		
15	Employees' Retirement System on the occasion of its seventy-fifth anniversary; does hereby		
16	record and recognize its contributions to this state; and does hereby extend much		
17	appreciation for LASERS' long, dedicated, and significant service to Louisiana.		
18	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the		
19	executive director for the Louisiana State Employees' Retirement System.
