 Provides relative to permanent placement of children in custody of the state. (gov sig)

Proposed law provides that DCFS shall conduct a diligent search for adult relatives of the child and for persons with a significant relationship to the child no later than 30 days from the date the child was taken into custody. Proposed law defines a diligent search. Proposed law provides that the court may excuse DCFS from considering a relative as a placement if the relative fails to demonstrate a willingness to provide a permanent home for a child. Proposed law provides that the priority placement of adoption shall include kinship care with another member of the child's family. Proposed law provides that if the court finds that a child under age 6 has been living in a stable home environment for the past 6 months, there shall be a rebuttable presumption that continuation of the child's placement with the current caregivers is in the child's best interests. Proposed law prohibits DCFS from making a change of placement absent court approval upon good cause shown.
