Subject: Reporting Hazardous Materials Under the Right-to-Know Law

Modifies definitions relative to hazardous materials reporting under the Right-to-Know Law

In present law, the Right-To-Know Law provides for the reporting of unauthorized releases from natural gas pipelines and establishes a reportable quantity of 1,000 pounds. Proposed law provides that natural gas pipelines: (1) are to be considered "facilities" under the Right-To-Know law and subject to the reporting requirements under the Right-to-Know Law; and (2) are not to be treated as "transport vehicles" or subject to reporting requirements under the laws regarding hazardous materials transportation and motor carrier safety. Proposed law changes the definition of "owner or operator" with the existing definition of "facility" as well as makes "facility" inclusive of pipelines, by referring to hazardous materials "in" a facility rather than "at" a facility.
