1 AN ACT To redesignate a portion of Louisiana Highway 3094 in Shreveport, Louisiana, as the "Rev. 2 3 Dr. Elbert W. 'Eddie' Giles Memorial Highway"; and to provide for related matters. 4 Be it enacted by the Legislature of Louisiana: Section 1. The portion of Louisiana Highway 3094, otherwise known as Hearne 5 6 Avenue, from the three-hundred through the four-hundred block, in Shreveport, Louisiana, 7 shall be known and hereby redesignated as the "Rev. Dr. Elbert W. 'Eddie' Giles Memorial 8 Highway". 9 Section 2. The Department of Transportation and Development or its contractors are 10 hereby directed to erect and maintain appropriate signage reflecting this designation provided local or private monies are received by the department equal to the department's 11 12 actual costs for material, fabrication, mounting posts, and installation of each sign, not to 13 exceed the sum of five hundred fifty dollars per sign.
