Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

HIGHWAYS: Redesignates a portion of Louisiana Highway 3094 in Shreveport as the "Rev. Dr. Elbert W. 'Eddie' Giles Memorial Highway"

1 AN ACT

2 To redesignate a portion of Louisiana Highway 3094 in Shreveport, Louisiana, as the "Rev.  
3 Dr. Elbert W. 'Eddie' Giles Memorial Highway"; and to provide for related matters.

4 Be it enacted by the Legislature of Louisiana:

5 Section 1. The portion of Louisiana Highway 3094, otherwise known as Hearne  
6 Avenue, from the three-hundred through the four-hundred block, in Shreveport, Louisiana,  
7 shall be known and hereby redesignated as the "Rev. Dr. Elbert W. 'Eddie' Giles Memorial  
8 Highway".

9 Section 2. The Department of Transportation and Development or its contractors are  
10 hereby directed to erect and maintain appropriate signage reflecting this designation  
11 provided local or private monies are received by the department equal to the department's  
12 actual costs for material, fabrication, mounting posts, and installation of each sign, not to  
13 exceed the sum of five hundred fifty dollars per sign.

Redesignates La. Hwy. 3094, specifically the 300 through the 400 blocks of Hearne Avenue, in Shreveport, La., as the "Rev. Dr. Elbert W. 'Eddie' Giles Memorial Highway".

Directs the Dept. of Transportation and Development (DOTD) to erect and maintain appropriate signage reflecting this highway designation provided local or private monies are

received by the DOTD equal to its actual costs for material, fabrication, mounting posts, and installation of each sign, not to exceed the sum of \$550 per sign.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by House Committee on Transportation, Highways and Public Works to the original bill:

1. Change the highway referenced in the redesignation from U.S. Hwy. 171 to La. Hwy. 3094.

The House Floor Amendments to the engrossed bill:

1. Change the name of the proposed highway redesignation from "Elbert W. Giles Memorial Highway" to "Rev. Dr. Elbert W. Giles Memorial Highway"
