REVENUE EXPLANATION

Proposed law is anticipated to decrease SGR from license fees by \$900. Proposed law excludes marine motors designed primarily for commercial or governmental purposes from being licensed or regulated by the LA Motor Vehicle Commission. The commission reports the loss of two licenses under this measure, \$500 for a recreational products distributor license and \$400 for a recreational products dealer license.
