1 AMENDMENT NO. 1

2 On page 1, line 2, after "enact" and before "of the Louisiana Revised Statutes" change "Part
3 X of Subchapter D of Chapter 5-D of Title 40" to "Subpart A-3 of Part III of Chapter 4 of
4 Title 22"

5 AMENDMENT NO. 2

6 On page 1, line 3, change "40:1227.1 through 1227.3" to "22:1020.51 through 1020.53"

7 AMENDMENT NO. 3

8 On page 1, line 8, after "Section 1." delete the remainder of the line in its entirety and insert
9 in lieu thereof the following:

10 "Subpart A-3 of Part III of Chapter 4 of Title 22 of the Louisiana"

11 AMENDMENT NO. 4

12 On page 1, line 9, change "40:1227.1 through 1227.3" to "22:1020.51 through 1020.53"

13 AMENDMENT NO. 5

14 On page 1, line 11, change "**PART X.**" to "**SUBPART A-3.**"

15 AMENDMENT NO. 6

16 On page 1, line 13, change "**§1227.1.**" to "**§1020.51.**"

17 AMENDMENT NO. 7

18 On page 2, line 3, change "**§1227.2.**" to "**§1020.52.**"

19 AMENDMENT NO. 8

20 On page 2, at the end of line 11, add the following:

21 "**For purposes of this Subpart, "participating provider" shall include any clinic,**
22 **hospital outpatient department or pharmacy under the common ownership or**
23 **control of the participating provider.**"

25 On page 2, line 15, change "**§1227.3.**" to "**§1020.53.**"

26 AMENDMENT NO. 10

27 On page 2, line 16, between "**issuer**" and "**shall**" insert

28 "**, pharmacy benefit manager, or their agent**"

1 AMENDMENT NO. 11

2 On page 2, line 17, after "**provider**" delete the remainder of the line, delete line 18, and on
3 line 19, delete "**participating provider,**"

4 AMENDMENT NO. 12

5 On page 2, line 22, between "**drug**" and "**because**" insert the following:

6 "**when all criteria for medical necessity are met,**"

7 AMENDMENT NO. 13

8 On page 3, line 1, between "**issuer**" and "**shall**" insert the following:

9 "**, pharmacy benefit manager, or their agent,**"

10 AMENDMENT NO. 14

11 On page 3, delete lines 2 through 18 in their entirety and insert in lieu thereof the following:

12 "**additional fee, or any other increased cost-sharing amount in addition to**
13 **applicable cost-sharing amounts payable by the covered person as designated**
14 **within the benefit plan to obtain the physician-administered drug when**
15 **provided by a participating provider. However, nothing in this Subpart shall**
16 **prohibit a health insurance issuer or its agent from establishing differing**
17 **copayments or other cost-sharing amounts within the benefit plan for covered**
18 **persons who acquire physician-administered drugs from other providers.**
19 **Nothing in this Subpart shall prohibit a health insurance issuer or its agent**
20 **from refusing to authorize or approve or from denying coverage of a**
21 **physician-administered drug based upon failure to satisfy medical necessity**
22 **criteria. For purposes of this Section, the location of receiving the**
23 **physician-administered drug shall not be included in the medical necessity**
24 **criteria.**"
