Amendments proposed by House Committee on Administration of Criminal Justice to Original House Bill No. 406 by Representative Bishop

1 AMENDMENT NO. 1

2 On page 1, line 2, after "Article 833" and before the comma "," insert "and to enact Code of
3 Criminal Procedure Article 833.1"

4 AMENDMENT NO. 2

5 On page 1, at the end of line 7, after "reenacted" insert "and to enact Code of Criminal
6 Procedure Article 833.1"

7 AMENDMENT NO. 3

8 On page 1, at the end of line 14, after the period "." add the following:

9 "Counsel accepting service and waiving the presence of the defendant shall use the
10 form provided in Article 833.1.

36 in these proceedings and he hereby appoints his above named legal counsel as his
37 agent(s) to accept service of notice to appear for those dates on his behalf, that he
38 accepts service of those dates through his counsel and that he expressly waives his
39 appearance for those dates and authorizes his counsel to appear on his behalf;

41 Affiant understands that the court, in its sole discretion may revoke its
42 acceptance of this waiver and require that affiant personally appear in open court on

1 subsequent court dates; that his counsel will also be notified; that a notice of
2 appearance will be mailed to affiant at his address of record and that defendant's
3 failure to appear at subsequent court date could result in the issuance of an arrest
4 warrant, a revocation of appearance bond and/or is punishable as contempt of court;

6 Finally, Affiant acknowledges that his current address is:
7 (Street, Apt/Lot No, City, State and Zip Code); and authorizes the
8 court to use this address for all notices, unless changed in writing by affiant.
