21	felony offense under R.S. 15:529.1 for the instant offense.
22	(b) The provisions of Subparagraph (a) of this Paragraph shall not apply to
23	any person who meets any of the following criteria:
24	(i) The instant conviction is a crime of violence under R.S. 14:2(B).
25	(ii) The instant conviction or any prior conviction, whether or not that prior
26	conviction was used in the habitual offender conviction under R,S, 15:529.1, is both
27	a crime of violence under R.S. 14:2(B) and a sex offense under R.S. 15:541.
28	(iii) The person would still qualify for a sentence of life imprisonment
29	without parole, probation, or suspension of sentence as a third or subsequent offense
30	under R.S. 15:529.1, as it was amended by Act Nos. 257 and 282 of the 2017
31	Regular Session."
