The bureau shall, upon request and after receipt of 19 20 fingerprint cards and other identifying information from the Louisiana Board of 21 Massage Therapy, make available to the Louisiana Board of Massage Therapy all 22 conviction information contained in the bureau's criminal history record and 23 identification files which pertain to the person seeking licensure with the Louisiana 24 Board of Massage Therapy. In addition, the fingerprints shall be forwarded by the 25 bureau to the Federal Bureau of Investigation for a national criminal history record 26 check.
