Proposed legislation revises existing law requiring the LA Department of Education (LDE) to develop a literacy assessment for students in Kindergarten through 3rd grade. Requires LDE to provide the assessment at no cost to each public school. Provides minimum requirements for the skills to be measured and the intended uses of the assessment. Requires the Board of Elementary and Secondary Education (BESE) to revise certification requirements relative to literacy. Requires public schools to develop a triennial foundational literacy skills plan. Repeals present law providing for a pilot project for dyslexia screening.


## **EXPENDITURE EXPLANATION**

The Department of Education (LDE) reports that it has budgeted existing Elementary and Secondary School Emergency Relief (ESSER) federal funding for the development of a literacy assessment as required by the proposed legislation. Further, LDE has developed a budget plan in the out years to reduce 3rd grade through high school assessment costs in order to fund the new assessment with existing SGF funding; therefore, LDE does not anticipate further costs associated with the development of this assessment.

If LDE is unable to sufficiently reduce its existing assessment costs to sufficiently implement the proposed legislation, it may require additional federal or SGF funding.
