Proposed law creates the LA Power-Based Violence Review Panel under the jurisdiction of the Board of Regents (BOR) and requires it to meet at least two times per year and up to a maximum of four times per year. Provides for membership of the panel who shall serve without compensation. Provides for the definition of power-based violence. Requires panel to (1) evaluate policies and practices of institutions of postsecondary education, management boards, and the Board of Regents (BOR) regarding reporting, investigating, and adjudicating power-based violence; (2) advise and assist institutions, management boards, and BOR in coordinating procedures to provide power-based violence prevention programs; (3) serve as an advisory agency to the legislature, the governor, the BOR, and the management boards of each postsecondary education system. Provides for cooperation of BOR, each postsecondary education management board and institution, and each law enforcement agency to make available all facts, records, information, and data required by the panel in carrying out its functions. Effective upon governor's signature.
