**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Ways and Means to Original House Bill No. 582 by Representative McFarland

1 AMENDMENT NO. 1

2 Delete Amendment Nos. 1 and 2 by the House Ways and Means Committee (#2098)

3 AMENDMENT NO. 2

4 On page 1, line 2, after "enact" delete the remainder of the line in its entirety and delete line  
5 3 in its entirety and at the beginning of line 4, delete "R.S. 47:818.12 and 818.111," and  
6 insert "Part II-A of Chapter 3 of Title 32 of the Louisiana Revised Statutes of 1950, to be  
7 comprised of R.S. 32:461, and R.S. 47:818.12(E),"

8 AMENDMENT NO. 3

9 On page 1, line 5, after "projects;" delete the remainder of the line in its entirety, delete lines  
10 6 and 7 in their entirety and insert the following:

11 "to provide for the excise tax levied on gasoline and diesel; to require a portion of  
12 the excise tax levied on gasoline and diesel to be dedicated into the Construction  
13 Subfund of the Transportation Trust Fund; to impose a road-use fee on electric and  
14 hybrid"

15 AMENDMENT NO. 4

16 On page 1, line 8, after "vehicles;" delete "to provide for the rate of the tax;" and insert "to  
17 impose a road-use fee on electric and hybrid vehicles;"

18 AMENDMENT NO. 5

19 On page 1, line 9, after "definitions;" delete the remainder of the line in its entirety and at  
20 the beginning of line 10, delete "audits;"

21 AMENDMENT NO. 6

22 In Amendment No. 3 by the House Ways and Means Committee (#2098), on page 1,  
23 between lines 15 and 16, insert the following:

24 "Section 1. Part II-A of Chapter 3 of Title 32 of the Louisiana Revised Statutes of  
25 1950, comprised of R.S. 32:461, is hereby enacted to read as follows:

26 PART II-A. ELECTRIC VEHICLES  
27 AND HYBRID VEHICLES

28 §461. Electric vehicles; hybrid vehicles; imposition of a road-use fee; collection;  
29 use of proceeds

30 A.(1) There is hereby levied a one-time road use fee of one thousand dollars  
31 on each electric vehicle which is operated upon the highways of this state and which  
32 is required to be registered and to pay registration license tax in accordance with the  
33 provisions of Chapter 4 of Subtitle II of this Title.

34 (2) There is hereby levied a one-time road use fee of five hundred dollars on  
35 each hybrid vehicle which is operated upon the highways of this state and which is

1 required to be registered and to pay registration license tax in accordance with the  
2 provisions of Chapter 4 of Subtitle II of this Title.

3 B. For purposes of this Section, the following terms shall have the following  
4 meanings:

5 (1) "Electric vehicle" shall mean a vehicle which is powered by one or more  
6 electric motors or energy stored in rechargeable batteries for propulsion.

7 (2) "Hybrid vehicle" shall mean a vehicle that uses gasoline, diesel fuel, or  
8 special fuels in combination with an electric motor for propulsion.

9 C. The fee imposed pursuant to the provisions of this Section shall be  
10 collected by the motor vehicle dealer from the purchaser at the time of sale of a new  
11 or used electric vehicle or a new or used hybrid vehicle. The fee shall be collected  
12 by the dealer and remitted to the office of motor vehicles in the same manner as all  
13 sales and use taxes are collected.

14 D. The commissioner of motor vehicles shall deposit the proceeds of the fee  
15 collected pursuant to the provisions of this Section into the treasury. After  
16 compliance with the requirements of Article VII, Section 9(B) of the Constitution of  
17 Louisiana, the treasurer shall deposit an amount equal to the proceeds of the fee  
18 imposed pursuant to the provisions of this Section into the Construction Subfund of  
19 the Transportation Trust Fund pursuant to the requirements of Article VII, Section  
20 27(B)(2) of the Constitution of Louisiana."

21 AMENDMENT NO. 7

22 In Amendment No. 3 by the House Ways and Means Committee (#2098), on page 1, at the  
23 beginning of line 16, delete "Section 1." and insert "Section 2."

24 AMENDMENT NO. 8

25 In Amendment No. 3 by the House Ways and Means Committee (#2098), on page 1, delete  
26 line 32 in its entirety and insert "Section 3.""
