 Authorizes the board of the Capital Area Groundwater Conservation District to assess fees for capital expenditures and nonpayment

Purpose of Bill: This bill authorizes the Capital Area Groundwater Conservation District (District) to assess fees to individual users for certain costs based on annual flows or specific costs for wells. In addition, this bill authorizes the District to assess late fees for non-payment of monthly or quarterly invoices.

This official also indicated that the District currently assesses the late fees authorized by the bill.
