22 A.(1)(a) Notwithstanding the provisions of R.S. 39:100.44, the treasurer shall utilize the resources of the Louisiana Main Street Recovery Program to 23 administer the Louisiana Port Relief Program. The treasurer may utilize up to five 24 25 percent of the monies in the Louisiana Port Relief Fund for administration of the 26 program. Notwithstanding any provision of law to the contrary, the treasurer may 27 enter into consulting services, professional services, and information and technology 28 services contracts for the purpose of the procurement of any goods or services necessary to implement and expedite the distribution of funds as emergency 29 30 procurements exempt from the provisions of the Louisiana Procurement Code and 31 corresponding rules and regulations. The cost of such contracts shall be considered 32 administrative expenses.

6	Business and Nonprofit Assistance Fund for administration of the program.
7	Notwithstanding any provision of law to the contrary, the Department may enter into

9	contracts for the purpose of the procurement of any goods or services necessary to

16	to COVID-19.

18	authority of any port area or port, harbor, and terminal district.
19	(4) Any port authority receiving funding pursuant to this Section shall meet
20	the following criteria:
21	(a) Had a physical and active operation in Louisiana as of March 1, 2020.
22	(b) Experienced a revenue loss of gross revenue for the period of January 1,
23	2020, through December 31, 2020, as compared to the gross revenue of the port
24	during the same period in 2019.
25	(4) The port authority seeking funding pursuant to this Section shall submit
26	verification of revenue loss and COVID-19 expenses to the treasurer.
27	B.(1) The Louisiana Small Business and Nonprofit Assistance Program is
28	hereby established as a component of the Louisiana Main Street Recovery Program.
29	The program shall provide grants to small businesses and eligible nonprofit
30	organizations, including public charities and faith-based organizations that provide
31	social services to the broader community, to administer aid to individuals impacted
32	by COVID-19. Any grant received pursuant to this Subsection shall not exceed
33	twenty-five thousand dollars per nonprofit organization.
34	(2) Any small business or eligible nonprofit organization receiving funding
35	pursuant to this Section shall meet the following criteria:

10	credit to the fund any federal monies allocated to Louisiana pursuant to the
11	Coronavirus Capital Projects Fund of the American Rescue Plan Act of 2021.

14	credited to the fund. Unexpended and unencumbered monies in the fund at the end
