Purpose of Bill: This bill creates the Franklin Parish Retired Employees Insurance Fund (FREIF) to pay insurance premiums for eligible retired sheriffs and deputy sheriffs and to pay for legal representation of the FREIF board. The FREIF will be financed by the Franklin Parish Sheriff at his/her discretion and money earned on investments. This bill also creates a 3 member investment advisory board to provide investment recommendations on the investment of funds in the FREIF.

EXPENDITURE EXPLANATION

This measure may increase annual local governmental expenditures for the Franklin Parish Sheriff's Office by \$9,528 starting in 2022, increasing to \$11,968 by 2026.

An official with the Franklin Parish Sheriff's Office indicated that the Sheriff's annual expenditures will increase by \$9,528 starting in 2022 and will increase to \$11,968 by 2026. These expenditures will be for financial and legal advisors (about 0.6% of FREIF fund balance per year). Costs for retiree insurance are not expected to change due to this bill because the Sheriff currently pays for retiree insurance. In addition, audit costs are not expected to change nor will board members be compensated for their service.

REVENUE EXPLANATION

This measure may increase annual local governmental revenue for the Franklin Parish Sheriff's Office by \$80,458 starting in 2022, increasing to \$102,834 by 2026.

An official with the Franklin Parish Sheriff's Office indicated that the Sheriff's Office plans to deposit \$1,500,000 into the FREIF initially in 2022 to pay retiree insurance. No additional contributions are expected to be made for fiscal years 2023 through 2026, but a review of annual operating budgets may lead to increased deposits. This money, which otherwise would have earned approximately 0.5% in interest annually in a bank account, will be invested and is expected to grow at 5.7% annually (an increase of 5.2% in the annual rate of return). This increase in the rate of return is expected to generate an additional \$80,458 annually in investment revenue starting in 2022, increasing to \$102,834 annually by 2026.
