EMPLOYMENT/WAGES-MINIMUM: Creates a task force to study minimum wage

A CONCURRENT RESOLUTION

2	To create a task force to study the feasibility of increasing the minimum wage rate and to			
3	submit a written report of the task force's findings and recommendations to the			
4	Legislature of Louisiana not later than thirty days prior to the convening of the 202			
5	Regular Session.			
6	WHEREAS, the Fair Labor Standards Act of 1938 was passed by Congress and			
7	subsequently signed into law on June 25, 1938 by President Franklin D. Roosevelt; and			
8	WHEREAS, through the Fair Labor Standards Act, the federal government			
9	established and set a minimum hourly wage that still applies today to all United States			
10	workers who are employed by companies with revenues of at least five hundred thousand			
11	dollars, including workers in hospitals, nursing homes, schools, government agencies, and			
12	those who are involved in interstate commerce; and			
13	WHEREAS, not only did the Fair Labor Standards Act establish a minimum hourly			
14	wage, but it also addressed and established overtime pay, recordkeeping, and child laborate			
15	standards affecting both full-time and part-time workers in the private sector and in federal,			
16	state, and local governments; and			
17	WHEREAS, despite these historical feats, one area of the Fair Labor Standards Act			
18	that receives plenty of polarizing discussion is the minimum wage rate, and more			
19	specifically the increase of minimum wage; and			

1	WHEREAS, since the first federal minimum wage rate was set in 1938, it has been			
2	raised only twenty-two times; and the last time the minimum wage rate was raised was or			
3	July 24, 2009, when it rose from six dollars and fifty-five cents per hour to seven dollars and			
4	twenty-five cents per hour; and			
5	WHEREAS, states are not required to create minimum wage laws and if a state does			
6	not have a set minimum wage rate then the federal minimum wage rate of seven dollars and			
7	twenty-five cents per hour will apply; and			
8	WHEREAS, when states have created minimum wage laws that are lower than the			
9	federal minimum wage then the federal minimum wage rate will apply for workers covered			
10	under the Fair Labor Standards Act; however, if a state's minimum wage rate is higher than			
11	the federal minimum wage rate then the state's higher minimum wage rate will apply; and			
12	WHEREAS, Louisiana is one of those states that currently does not have any			
13	minimum wage rate laws, and therefore the current federal minimum wage rate of seven			
14	dollars and twenty-five cents per hour applies in this state; and			
15	WHEREAS, there have been discussions in Washington, D.C. about potentially			
16	increasing the minimum wage rate to fifteen dollars per hour gradually by 2025; and			
17	WHEREAS, if this comes to fruition, Louisiana would not need to act on a state level			
18	and create minimum wage laws increasing the rate; however, with uncertainty at the federal			
19	level, the state must take action by at least studying the feasibility of increasing the			
20	minimum wage rate statewide; and			
21	WHEREAS, one of the arguments for increasing the minimum wage rate is that the			
22	cost of living has continuously increased while the minimum wage rate has remained the			
23	same since 2009; and			
24	WHEREAS, some proponents of a minimum wage increase have argued that			
25	individuals who earn higher wages have a lesser need to rely on state and federal			
26	government expenditures, which would result in projected reductions in these expenditures			
27	and			
28	WHEREAS, proponents have also argued that an increase in wages is beneficial to			
29	both companies and employees because higher wages would improve employee morale,			
30	which in turn would increase employee retention and reduce hiring and training costs; and			

1	WHE	REAS, some opponents of a minimum wage increase have argued that		
2	increasing minimum wage would force business owners, who would be unable to afford an			
3	increased rate, to lay off employees, thus subsequently raising unemployment rates; and			
4	WHEREAS, opponents have also argued that increasing minimum wage would			
5	increase the price of consumer goods; and			
6	WHEREAS, all of these varying viewpoints, and more, need to be studied and			
7	considered in order to determine if it is feasible to raise the minimum wage rate in this state.			
8	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby			
9	establish the Minimum Wage Task Force to study the feasibility of increasing the minimum			
10	wage rate in the state and to submit a written report of its findings and recommendations to			
11	the Legislature of Louisiana not later than thirty days prior to the convening of the 2022			
12	Regular Session.			
13	BE IT	FURTHER RESOLVED that the membership of the task force shall be as		
14	follows:			
15	(1)	The secretary of the Louisiana Economic Development or his designee.		
16	(2)	The secretary of the Louisiana Workforce Commission or his designee.		
17	(3)	One representative from the Louisiana American Federation of Labor and		
18		Congress of Industrial Organizations.		
19	(4)	One representative from the Louisiana Budget Project.		
20	(5)	One representative from the Workplace Justice Project.		
21	(6)	One representative from the Louisiana Association of Business and Industry.		
22	(7)	One representative from the National Federation of Independent Business.		
23	(8)	One representative from the Louisiana Women Lead.		
24	(9)	One representative from the Louisiana Community and Technical College		
25		System.		
26	BE IT	FURTHER RESOLVED that the Louisiana Workforce Commission shall		
27	provide staff support as needed by the task force.			
28	BE IT FURTHER RESOLVED that the task force shall convene its first meeting by			
29	September 1, 2021, and shall meet as frequently as it deems necessary for the timely			
30	performance of its duties.
