- 34 §302.18 Disposition of certain collections in Lafayette Parish
- * * *
- B. The monies in that fund deposited pursuant to this Section shall be subject to annual appropriation by the legislature and shall be used for planning, development, and

- 1 capital improvements at or adjacent to the Cajundome site and operating costs of the
- 2 <u>Cajundome</u>. For the purposes of this Section, "capital improvements" shall mean
- 3 expenditures for acquiring lands, buildings, equipment, or other permanent properties, or for
- 4 their construction, preservation, development, or permanent improvement, or for payment
- 5 of principal, interest, or premium, if any, and other obligations incident to the issuance,
- 6 security, and payment of bonds or other evidences of indebtedness associated therewith.
- Section 20. Subpart H of Part II-A of Chapter 1 of Subtitle I of Title 39 of the Louisiana Revised Statutes of 1950, comprised of R.S. 39:100.11, is hereby enacted to read as follows:

SUBPART H. JEAN BOUDREAUX SETTLEMENT COMPROMISE FUND

- 11 §100.11. Jean Boudreaux Settlement Compromise Fund; purpose
 - A. There is hereby created in the state treasury, as a special fund, the "Jean Boudreaux Settlement Compromise Fund", hereinafter referred to in this Section as the "fund".
- B. Notwithstanding any provision of law to the contrary, the state treasurer is hereby authorized and directed to transfer \$15,000,000 from the State General Fund (Direct) into the fund.
 - C. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on investment of monies in the fund shall be credited to the fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund.
- 21 22 D. Monies in the fund shall be used for partial payment of the judgment captioned 23 "Jean Boudreaux and the Victims of the Flood on April 6, 1983 on the Tangipahoa River versus the State of Louisiana, Department of Transportation, et al.", rendered on June 10, 24 25 2005, bearing Number 2004 CA 0985, on the docket of the Court of Appeal, First Circuit, 26 state of Louisiana. The monies payable pursuant to this Section shall be paid to the plaintiffs 27 through Hancock Bank, as escrow agent, into escrow account number 1097000229. Payment shall be made as to this judgment only after presentation to the state treasurer of 28 29 documentation required by the state treasurer. Payments out of the fund shall not be made 30 without prior approval of the compromise agreement by the Joint Legislative Committee on 31 the Budget."
