5	Health Care Centers, Inc., was established in 2004 as a Federally Qualified Health Center
6	with a mission to provide access to high quality, affordable health care to citizens of

8	WHEREAS, InclusivCare has an annual economic impact of \$30 million and is
9	directly responsible for \$16 million in savings to the overall health system in Louisiana; and
10	WHEREAS, InclusivCare manages a network of five community clinics, located in
11	Kenner, Lafitte, Avondale, Marrero, and on the L.W. Higgins High School campus; it has
12	leveraged its resources to aid the statewide efforts to abate the spread of the COVID-19 virus
13	and has participated in nearly forty community events, since May 2020, with the help of the
14	Jefferson Parish Council; and
15	WHEREAS, InclusivCare is currently involved in academic research with Tulane
16	University and has partnered with the Louisiana Department of Health to prepare for mass
17	COVID-19 vaccinations; and
