HOUSE RESOLUTION NO. 109

CIVIL/INTERDICTION: Requests the Louisiana State Law Institute to study provisions of law relative to the consent of a curator to an abortion or sterilization of an interdict

A RESOLUTION

2	To urge and request the Louisiana State Law Institute to study provisions of law relative to
3	consent of a curator to an abortion or sterilization of an interdict, and to report its
4	findings to the House of Representatives of the Legislature of Louisiana no later than
5	February 1, 2022.
6	WHEREAS, persons with disabilities have equal personal dignity and human rights
7	as all other individuals; and
8	WHEREAS, any invasion of the autonomy of a person with a disability must have
9	a strong legal justification; and
10	WHEREAS, the practice of sterilizing individuals with disabilities and aborting
11	pregnancies of persons with disabilities without their consent began based on flawed eugenic
12	principles of hereditary inferiority; and
13	WHEREAS, the legislature rejects forced sterilization and forced abortion based on
14	negative stereotypes about persons with disabilities, as such stereotypes are immoral and
15	inconsistent with the values of the citizens of this state; and
16	WHEREAS, Code of Civil Procedure Article 4566 allows a person with a disability
17	who has been interdicted or placed under a continuing tutorship to be forcibly sterilized or
18	receive a forced abortion with the approval of a judge; and
19	WHEREAS, the current law in Louisiana establishes no process, legal standard, or
20	burden of proof and provides inadequate legal protections for the person with a disability
21	who is faced with the possibility of a forced sterilization or forced abortion; and

1	WHEREAS, in the absence of a governing legal standard, the judicial authorization
2	of a forced sterilization or forced abortion may be based on stigma, personal bias, or
3	negative stereotypes about persons with disabilities; and
4	WHEREAS, the current law allowing forced sterilization and forced abortion is
5	inconsistent with fundamental principles of human rights and equal dignity for all
6	individuals; and
7	WHEREAS, the law should include a set of robust procedural protections for persons
8	with disabilities who have been interdicted or placed under a continuing tutorship; and
9	WHEREAS, procedural protections should include specific requirements to assess
10	the consent and wishes of the individual with a disability; and
11	WHEREAS, the procedural protections should include notice, the appointment of a
12	curator or supported decision-maker, and appointed counsel; and
13	WHEREAS, the law should require specific timelines in the case of a legal
14	proceeding seeking authorization for abortion; and
15	WHEREAS, the law should enumerate specific requirements of proof, allocate the
16	burden of proof, and set the standard to which each fact must be proven; and
17	WHEREAS, the law should be written so as not to interfere with necessary medical
18	care.
19	THEREFORE, BE IT RESOLVED that the House of Representatives of the
20	Legislature of Louisiana urges and requests the Louisiana State Law Institute to study
21	provisions of law relative to the consent of a curator to an abortion or sterilization of an
22	interdict, and to report its findings to the House of Representatives no later than February
23	1, 2022.
24	BE IT FURTHER RESOLVED that the Legislature of Louisiana does hereby urge
25	and request the Louisiana State Law Institute to include representatives of Disability Rights
26	Louisiana and Louisiana Right to Life, to the extent not already included in the study group.
27	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
28	director of the Louisiana State Law Institute.
