CONSERVATION: Creates the Outdoor Conservation Study Group to study conservation funding mechanisms and programs

1	A CONCURRENT RESOLUTION			
2	To create the Outdoor Conservation Study Group, to study and make recommendations			
3	regarding conservation funding mechanisms as well as conservation programs that			
4	could be generated from such funding.			
5	WHEREAS, Louisiana is blessed with abundant fish and wildlife species and			
6	globally important lands and waters which provide important habitats, improve the quality			
7	of drinking water, and support commercial and recreational activities; and			
8	WHEREAS, Louisiana's agricultural industry includes working lands and forests that			
9	are essential to sustainable habitats and economic productivity; and			
10	WHEREAS, Louisiana is known as "Sportsman's Paradise" because its lands and			
11	waters offer exceptional opportunities for both commercial and recreational activities that			
12	inject billions of dollars into our economy annually; and			
13	WHEREAS, during the COVID-19 pandemic, visitation to outdoor areas increased			
14	dramatically and the mental and physical health benefits of access to such areas have been			
15	documented; and			
16	WHEREAS, conservation and preservation of these important lands and waters will			
17	ensure that the value they provide is available to future generations; and			
18	WHEREAS, many of Louisiana's important habitats are diminishing with inadequate			
19	funding and resources to conserve them; and			

1	WHEREAS, many of our neighboring states have increased investments in			
2	conservation funding in order to leverage other funding opportunities for important habitats			
3	in their state; and			
4	WHEREAS, Louisiana is missing opportunities for matching funds available through			
5	public and private sources that could be used to conserve important lands and waters in			
6	urban and rural areas throughout our state; and			
7	WHEREAS, many states in the Southeast region have determined that establishin			
8	a dedicated source of conservation funding has allowed them to greatly leverage their			
9	investment in conserving important habitats and thirty-eight states have similarly dedicated			
10	funding; and			
11	WHEREAS, states have utilized different mechanisms to increase investments in			
12	conservation funding, resulting in both conservation of important habitats as well as			
13	increasing revenues to the state's economy; and			
14	WHEREAS, the identification of financial opportunities and structures that would			
15	provide sustained funding for enhanced conservation efforts is critical to the preservation			
16	of fish and wildlife species and habitats, the improvement of drinking water, and the			
17	continued support of commercial and recreational outdoor activities; and			
18	WHEREAS, establishing dedicated sources of funding and investment mechanisms			
19	based on a comprehensive study of potential solutions could generate tens of millions of			
20	dollars for conservation in Louisiana.			
21	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby			
22	create the Outdoor Conservation Study Group, whose duties shall be to study and make			
23	recommendations regarding conservation funding and provides that, at a minimum, the study			
24	shall include the following:			
25	(1) Potential mechanisms to increase conservation funding for the state of			
26	Louisiana.			
27	(2) Potential programs for which such funds could serve as match.			
28	(3) The purpose for which the conservation funds may be used.			
29	(4) An administrative structure for the funds, including criteria for project			
30	selection and method of disbursement.			

1	BE IT FURTHER RESOLVED that the study group shall be composed of the		
2	following members:		
3	(1)	The governor or his designee.	
4	(2)	The executive assistant for the Governor's Office of Coastal Activities or his	
5		designee.	
6	(3)	The commissioner of administration or his designee.	
7	(4)	The secretary of the Department of Wildlife and Fisheries or his designee.	
8	(5)	The secretary of the Department of Natural Resources or his designee.	
9	(6)	The commissioner of the Department of Agriculture and Forestry or his	
10		designee.	
11	(7)	The lieutenant governor or his designee.	
12	(8)	One member appointed by the speaker of the House of Representatives.	
13	(9)	One member appointed by the president of the Senate.	
14	(10)	The chairman of the House Committee on Natural Resources and	
15		Environment or his designee.	
16	(11)	The chairman of the Senate Committee on Natural Resources or his designee.	
17	(12)	Three members selected by the governor from nonprofit conservation	
18		organizations having offices in Louisiana and engaged in conservation efforts	
19		in the state.	
20	(13)	One member from the United States Fish and Wildlife Service.	
21	(14)	One member from the United States Department of Agriculture, Natural	
22		Resource Conservation Service.	
23	BE IT FURTHER RESOLVED that the members from the United States Fish and		
24	Wildlife Service and the United States Department of Agriculture shall be nonvoting		
25	members.		
26	BE IT FURTHER RESOLVED that the member appointed by the speaker of the		
27	House of Representatives shall call the first meeting of the study group at which meeting the		
28	study group shall select a chair and other officers it deems necessary.		
29	BE IT FURTHER RESOLVED that the Louisiana office of The Nature Conservancy		
30	is hereby requested to provide any necessary staff support to the study group.		

- BE IT FURTHER RESOLVED that the study group shall submit a report with its
- 2 recommendations to the House Committee on Natural Resources and Environment and the
- 3 Senate Committee on Natural Resources by February 1, 2022.
- 4 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 5 governor of the state of Louisiana, the executive assistant for the Governor's Office of
- 6 Coastal Activities, the commissioner of administration, the secretary of the Department of
- Wildlife and Fisheries, the secretary of the Department of Natural Resources, the Louisiana
- 8 office of The Nature Conservancy, the commissioner of the Department of Agriculture and
- 9 Forestry, the lieutenant governor, the principal deputy director of the United States Fish and
- Wildlife Service, and the acting chief of the Natural Resource Conservation Service.

Creates the Outdoor Conservation Study Group to study and make recommendations regarding conservation funding mechanisms as well as conservation programs that could be generated from such funding.

Provides for the following members:

- (1) The governor or his designee.
- (2) The executive assistant for the Governor's Office of Coastal Activities or his designee.
- (3) The commissioner of administration or his designee.
- (4) The secretary of the Dept. of Wildlife and Fisheries or his designee.
- (5) The secretary of the Dept. of Natural Resources or his designee.
- (6) The commissioner of the Dept. of Agriculture and Forestry or his designee.
- (7) The lieutenant governor or his designee.
- (8) One member appointed by the speaker of the House of Representatives.
- (9) One member appointed by the president of the Senate.
- (10) The chairman of the House Committee on Natural Resources and Environment or his designee.
- (11) The chairman of the Senate Committee on Natural Resources or his designee.

- (12) Three members selected by the governor from nonprofit conservation organizations having offices in La. and engaged in conservation efforts in the state.
- (13) One member from the U.S. Fish and Wildlife Service.
- One member from the U.S. Dept. of Agriculture, Natural Resource Conservation Service.

Provides that the members from the U.S. Fish and Wildlife Service and the U.S. Dept. of Agriculture are nonvoting members.

Provides that the member appointed by the speaker must call the first meeting. Provides that the study group must select a chair and other officers at the first meeting. Requests the La. office of the Nature Conservancy to provide any necessary staff support to the study group.

Provides for the submission of a report to the House Committee on Natural Resources and Environment and the Senate Committee on Natural Resources by Feb. 1, 2022.

## Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on House and</u> Governmental Affairs to the engrossed resolution:

- 1. Specifies that the member appointed by the speaker of the House of Representatives shall call the first meeting and at which meeting the study group shall select a chair and other officers it deems necessary.
- 2. Requests the La. office of The Nature Conservancy to provide any necessary staff support to the study group.
