AN ACT

2 To amend and reenact R.S. 17:3914(M) and to repeal R.S. 17:3914(M), relative to student 3 information; to provide for the continued effectiveness of provisions that require 4 school governing authorities to share certain student information with the 5 Department of Children and Family Services for the purpose of facilitating the 6 administration of the pandemic electronic benefits transfer program and that provide 7 exceptions; to authorize the sharing of additional information; to provide for the 8 sharing of such information for the additional purpose of facilitating the 9 administration of the summer electronic benefits transfer program; and to provide for 10 related matters. 11 Be it enacted by the Legislature of Louisiana: 12 Section 1. R.S. 17:3914(M) is hereby amended and reenacted to read as follows: 13 §3914. Student information; privacy; legislative intent; definitions; prohibitions; 14 parental access; penalties 15 16 M.(1) Notwithstanding any provision of law to the contrary and except as 17 provided in Paragraph (2) of this Subsection, the governing authority of each public 18 or nonpublic school or other entity that participates in a meal program through which 19 students are eligible for the pandemic electronic benefits transfer program or summer 20 electronic benefits transfer program shall share student information with the 21 Department of Children and Family Services for the purpose of facilitating program 22 administration, including but not limited to the automatic issuance of benefits to 23 eligible families. Such information shall be limited to the first name, middle name,

1 last name, address, school site code, student unique identifier, and date of birth of 2 each student eligible for free or reduced price meals at school. 3 (2) Such a governing authority shall not share a student's information if his 4 parent or legal guardian has chosen not to share information pursuant to the policy 5 of the governing authority. 6 Section 2. R.S. 17:3914(M) is hereby repealed in its entirety. 7 Section 3.(A) Section 1 and this Section of this Act shall become effective upon 8 signature of this Act by the governor or, if not signed by the governor, upon expiration of 9 the time for bills to become law without signature by the governor, as provided by Article 10 III, Section 18 of the Constitution of Louisiana. If this Act is vetoed by the governor and 11 subsequently approved by the legislature, Section 1 and this Section of this Act shall become effective on the day following such approval. 12 13 (B) Section 2 of this Act shall become effective on December 31, 2022.
