HEALTH/CANCER: Requests the Louisiana Department of Health to establish a pilot program to increase prostate cancer awareness and education

| 3 | increase prostate cancer awareness and education by implementing more efficient |
| 4 | screening and learning tools for men, specifically uninsured, middle-aged, African |
| 5 | American males. |
| 6 | WHEREAS, prostate cancer is the most commonly diagnosed cancer in American |
| 7 | men; and |
| 8 | WHEREAS, prostate cancer is the second leading cause of cancer death in the United |
| 9 | States among males; and |
| 10 | WHEREAS, one in every seven men will be diagnosed with prostate cancer over the |
| 11 | course of his lifetime; and |
| 12 | WHEREAS, the American Cancer Society estimates that in 2021, in the United |
| 13 | States, there will be over two hundred forty thousand new cases and more than thirty-four |
| 14 | thousand deaths from prostate cancer; and |
| 15 | WHEREAS, approximately three thousand nine hundred men in Louisiana are |
| 16 | expected to be newly diagnosed in 2021; and |
| 17 | WHEREAS, there are typically no noticeable symptoms of prostate cancer in its |
| 18 | early stages; and |
| 19 | WHEREAS, nearly one million American men have prostate cancer and are unaware |
| 20 | of their condition; and |

| 1 | WHEREAS, compared to Caucasian males, African American men are more likely |

| 2 | to develop prostate cancer and are twice as likely to die from the disease; and |
| 3 | WHEREAS, African American men are also more likely than men of other races to |
| 4 | be diagnosed with advanced stages of the disease; and |
| 5 | WHEREAS, low-grade prostate cancer, in its early stages, has more aggressive |
| 6 | features in African Americans than in people of other races; and |
| 7 | WHEREAS, ongoing research promises further improvements in prostate cancer |
| 8 | prevention, early screening, early detection, and treatment; and |
| 9 | WHEREAS, early detection and treatment offer prostate cancer patients the best hope |
| 10 | for a full recovery, and improving patient outcomes depends a great deal on increasing |
| 11 | public awareness of prostate cancer and its risk factors; and |
| 12 | WHEREAS, additional focus is needed for outreach and education for uninsured |
| 13 | African American men on the benefits of prostate cancer screening, referral services, and |
| 14 | treatment options; and |
| 15 | WHEREAS, educating people in the United States, including healthcare providers, |
| 16 | about prostate cancer and early detection strategies is crucial to saving lives and preserving |
| 17 | families; and |
| 18 | WHEREAS, establishing a pilot program with the Louisiana Department of Health |
| 19 | to increase prostate cancer education and testing for uninsured African American men in |
| 20 | Louisiana could save lives by focusing on men of African descent over fifty years old and |
| 21 | providing prostate cancer screening, referral services, and treatment services along with |
| 22 | comprehensive outreach and education activities to ensure awareness and utilization. |
| 23 | THEREFORE, BE IT RESOLVED that the Legislature of Louisiana requests the |
| 24 | Louisiana Department of Health to establish a pilot program to increase prostate cancer |
| 25 | awareness and education by implementing more efficient screenings and learning tools for |
| 26 | men, specifically uninsured, middle-aged, African American males. |
| 27 | BE IT FURTHER RESOLVED that the department shall submit its findings to the |
| 28 | Louisiana Legislature on the Prostate Cancer Pilot Program no later than February 1, 2022. |
